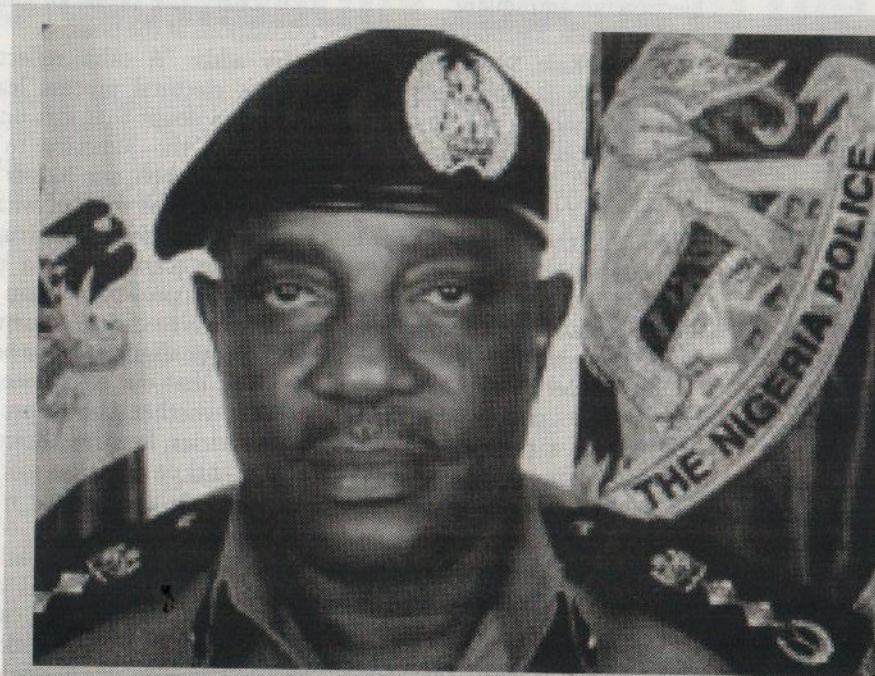
Alleged Murder: Family Seeks IGP Arase's Intervention

Having exhausted all means of getting results of findings into the death of their daughter, the family of Blessing Adighibe Nweke, a former staff of the Budget Office in the Presidency has taken its cry to the Inspector General of Police, IGP, Solomon Arase. Ejike Ejike reports.

On November, 2, 2010, Blessing Nweke, met her untimely death through an alleged motor accident on her way to the East and despite various directives to unravel the mystery behind her death, there is to me no conclusions as to what caused her death.

Recently, the immediate younger of late Nweke and Ifeanyi Adighibe has cried to the IGP Arase and other Nigerians to assist him unravel who and what killed his only sister, who was said to have been married to one Charles Nweke

Recall that the former Inspector-General of Police, Mohammed Abubakar had during his tenure ordered for a full scale investigation to unravel the circumstances that led to the untimely death of Mrs Nweke but up until he left office, there was noting concrete.

Adighibe, who is the next of kin of the deceased, had in his petition May, 30, 2014 to IGP Mohammed Abubakar titled, "Request For The Withdrawal of My Case At FCID Area 10, Garki to a More Neutral Section of Your office for Proper Investigation and Action" and made available to Leadership, alleged a calculated plan to deny him of true justice over the real cause of his sister's death in the hands of Charles Nweke, the deceased estranged husband and illegal ceasing and conversion of the deceased

properties worth millions of naira for his personal use without recourse to the pains the complainant has been facing since the death of their daughter.

In the latest appeal Adighibe made to Arase, he called for urgency and public interest and urged him to personally wade into the alleged killing of his elder sister.

While narrating his struggle to LEADERSHIP, Adighibe stated that he will have no other option than to petition the IGP's Complaint Report Unit, CRU if the police investigators fails to defend

the defenseless like him from his oppressors who say justice is only meant for the rich in the society.

Adighibe had on August, 11, 2015 wrote a reminder to the Inspector-General of Police, IGP Solomon Arase titled Re: "Petition Against Mr. Charles now when they alleged that they have concluded their investigations and sent the case file to the DIG for further directive on the matter on whether to charge it to court or not.

Man In EFCC Net For Allegedly Stealing Land Document

A middle aged man, Daniel Onyebuchi Anyikai is currently cooling off at a cell after he was nabbed by the operatives of the Economic and Financial Crimes Commission, EFCC, for fraud and criminal conspiracy.

Anyika was said to have sometime in August, 2008 allegedly conspired with one Mohammed Lawal to steal a title document of a parcel of land situated at Plot No.921, Katampe B07, Abuja belonging to one Alhaji Lawal Umar Aminu.

The accused was arraigned before Justice C.S Oriji of the FCT High Court sitting in Apo, Abuja on a six-count charge of obtaining by false pretence, criminal conspiracy and forgery, offences, which are contrary to Section 317 of the Penal Code. Particulars of one of the counts read.
