There were uncontrollable shootings by the Police to scare away the opposition and make sure the ordinary masses do not vote. It was of public knowledge that the area police commander was bought over by the state gov-ernor; a jeep was presented to him a day to the election. The police sponsored by the state governor Chief Achike Udenwa and the council chairman (Chidi Obasi) ran away with the ballot boxes while the election was supposed to be on. An AC member from Isiozi ward was stabbed to death. INEC officials were bought over

to make way for people who were brought to vote for APGA and the PDP. They were forced to thumbprint based on their in-

Similar events took place in other local governments in Orlu zone of Imo State. The PDP leaders and governor were seen

threatening the opposition that their troubles in the governorship election is a minor thing compared with what will happen to them at on coming presidential election. According to them, people should be ready to lose their lives.

Anambra State: the opposition parties, Action Congress, DPP ANPP, APGA ,FP, PMP, ADC, APS had a press conference on the irregularities and went to INEC to submit the report of their protest. They discovered, that there were over one thousand policemen and eight hundred militarymen fully armed and they were denied ac-

Enugu State: the oppsition parties, AC, Accord Party, Labour and DPP organised a press conference at Veronica Street, GRA Enugu and moved to the INEC office to register their protest but were chased away by the police with teargas and in the process one of the teargas containers smashed the windscreen of Chief Dubem Onyia, the Action Congress governorship candidate.
