"We were all doing our business on the road when the vehicle started coming in on top speed. As soon as we saw it, everybody started running helter-skelter be-cause it was obvious that the driver had lost control", recalled one of the petrol hawkers at the scene of the accident.

The Divisional Police Officer (DPO) in charge of Sapele Police Station, Mr. Danjuma Kromda, could not be reached for comments but a police officer confirmed the report. He said the driver of the vehicle had been arrested.

A source at the station said the driver might be charged with murder and driving under the influence of alcohol as he was suspected to be drunk.

Meanwhile, the remains of the victims have been deposited in the morgue of the Sapele General Hospital.


night.
