Militants kill naval officer in Bayelsa

•MEND claims responsiblity • Senators, Niger Delta youths meet

ENATORS, who were on a fact-finding mission to the oil city of Warri, Delta State, got yesterday a first-hand information.

Their visit coincided with the killing of a naval officer by militants in an all-night attack on a vessel protecting Anglo-Dutch oil giant, Shell installation in Bayelsa.

Four other naval personnel were injured, een as 23 Senators arrived Warri for a parley with restive youths in the area.

The officer (name withheld) was feared dead on Tuesday night in an attempt by armed militants to seize the NNS Obula, one of the largest gunboats in the services of the Navy.

The gunmen planned to hijack the armoury in the gunboat, which came into the operation of the Navy in 2004.

Five officers and ratings sustained varying degrees of gunshot wounds from the resultant attack, which

occurred around the Funiwa Platform in the Penington River estuary, Bayelsa State.

The gunboat was one of several deployed by the Chief of Naval Staff, Ganiyu Adekaye to protect the oil fields, including the EA Field of Shell Petroleum devélopment Company

(SPDC).
The Information Officer of the Naval Base in Warri, Lieutenant Sikiru Adigun confirmed that an officer and four ratings were shot by the militants, but denied that any of the men died.

The wounded naval men were recuperating at various private hospitals in the oil city yesterday evening.

It was gathered that the armed youths launched the attack from no fewer than 15 speed boats at about 11:16 pm on Tuesday, but were repelled by the naval team, who engaged them in a

From Shola O'Neil, Warri Isaac Ombe, Yenagoa RPGs (rocket propelled grenade) where first shot into the gunboat by the militants, who later opened fire on the officer and soldiers who came out to

defend it. Adigun, informed that at least one of the invaders was confirmed dead, while scores others escaped with severe gunshot after the defeat...

He said, "I can-tell you with confidence that one of the invaders was killed; am confirming this because we have saw the corpse, but several others escaped with gunshot wounds and others may have died too, but am not sure since we do not have the death.

A Shell Petroleum Development Company (SPDC) security official also informed that the naval personnel were stationed at the installation to keep surveillance.

"We got a report that lengthy gun-duel. militants attacked the navy wessel NNS Obula at 2105 hours. The vessel was Edward Ekpoko and detailed to protect the EA Matthew Itsekure, led Itsekiri oilfield operated by Shell. One navy officer was killed while four were injured," the Shell security official said.

The state security service (SSS) also confirmed the attack, but said no hostages were taken from the Anglo-Dutch oil facility.

The Senators, led by senator Kabiru Gaya, mét with leaders of Ijaw and Itsekiri groups in the state at the Governor's Office Annexe with Governor Emmanuel Uduaghan in attendance.

There were, however, doubts that the senators would carry out a planned visit to the camps of the militants as earlier scheduled because of what a source described as "logistics problem."

In a statement made available signed by, its leader Jomo Ubomo, Movement for the Emancipation of Niger Delta (MEND) described the Naval war ship as a sitting duck says the attack was to tell the Oil companies and the Nigerian government that military presence in the Oil rich region cannot stop them from their campaigns.

The statement on the militants' website reads in part: The attack was to again proof to the oil majors and the Nigerian government that the presence of the military in the Niger Delta can not deter an attack nor provide protection to oil facilities when we decide to attack them. It is only the presence of justice that can.

"The NNS Obula was a sitting duck and this attack again exposed the incompetence of the Navy; especially in the night time warfare.

"During the last military exercise, the Chief of Naval Staff admitted that "due to the presence of frog' the exercise had to be called off. We found that statement laughable, ridiculous and pathetic considering our fighters can navigate in pitch darkness at speed of up to kilometer per hour," it said.
