ONDO

In Ondo, Dr. Tayo Dairo and Sola Oludipe who were acting as Chairman and Secretary emerged unopposed. Mrs. Folake Akinjoko was unanimously elected women leader.

Governor Olusegun Agagu praised members of the party for conducting themselves in a peaceful and orderly manner, describing PDP as a party that recognized quality and hard work

A 29-man consensus executive emerged in Delta, ending the crisis rocking the party in the state.

Chief Peter Nwoboshi, a foundation member of the party and a one-time Commissioner for Agriculture and Political Adviser to former Governor James Ibori, emerged chairman. Chief Ighoyota Amori, Vice chairman and Chief Solomon Ogba, Secretary.

<u>OGUN</u>

In Ogun where former Deputy Senate President Ibrahim Mantu oversaw the congress, Chief Joju Fadairo was returned as chairman.

Mantu, condemned what he called "muscle politics" that dogged that year's elections.

He said it was an indictment to the PDP that today, the courts are voiding the victories of its members at the last general elections, 'not necessarily because of election rigging but because the internal processes that threw up such persons for elections were flawed, leading the courts to declare it as inconsistent with the party's own constitution'

EKITI

A group which styles itself as the Ekiti Progressives rejected what it called the illegal and unconstitutional emergence of the new executive.

It said contrary to the will and the decision of the majority of the party to have a proper election, Speaker Femi Bamisile suddenly assumed the position of the returning officer and went ahead to announce a set of government anointed candidates. It is noted by the progressives in the PDP that delegates from the 16 local governments were still going through accreditation when the speaker hijacked the microphone to announce the government list.

Delegates were not al-. lowed to vote for candidates of their choice, it said.

In a statement by its leader Chief Sesan Fatoba, the group appealed to the PDP National Executive Council, the PDP National Convention committee and the PDP Board of Trustees to reject the government candidates who would not be potent to make the PDP in the state viable, attractive and popular among Ekiti people.

In Rivers State, former National Vice Chairman. South-South, Godspower Ake emerged chairman after Henry Odili and Elemchukwu Ogbowu stepped down for him.

Adokye Oruwaro was elected secretary.

**BAYELSA** 

In Bayelsa, parallel congresses was championed by Dr George Fente, special adviser to the governor on political affairs. The other was led by the outgoing chairman Chief Fred Agbedi.

**GOMBE** 

In Gombe, 28 members executive emerged by consensus.

All but one member of theformer executive were returned unopposed.

Other executive members include Malam Abubakar Gabdo, Deputy Chairman, Mr Zakari Musa, Secretary, Malam Muniru and Adamu, Treasurer.

Also elected were Mr Abubakar Muntari, Financial Secretary, Mr Adamu Gadam, Publicity Secretary, Mr Jacob Lawan, Legal Adviser, and Mrs Halima Todo, Women Leader.

<u>OYO</u>

In Oyo where the party defied court order to hold its congress the incumbent chairman Dejo Afolabi who is on pilgrimage to Jerusalem was returned unopposed.

**TARABA** 

The PDP chairman in Taraba, Alhaii Abdulmumini Vakki, réturned unopposed for a second term.

Similarly, all executive members were also returned based on a consensus reached by party stakeholders and elders.

**KWARA** 

At a peaceful congress in Ilorin, a new executive emerged for the party in \*Kwara State. The executives are led by Alhaji Yusuf Aiyedun (Chairman) and Hon. Issa Bawa, Vice Chairman, Alhaji Yekini Ilobu (Ilorin West) and Hajia Mushmat Ibrahim retained their seats as Secretary and Women Leader.

Alhaji Mariam Al-Hassan (Edu), the former Public Relations officer is now elected the New Youth Leader. Alhaji Isiaka Dan Mairomu, Public Relations Officer, Alhaji Aliyu Mohammed Auditor and Hajia Ramatu Ibrahim, elected as Finan-

cial Secretary.

Continued from page 1 House of doing the bidding of the Executive arm. They claimed that the leadership has not been carrying members along on the recurrent vote for the House Services Committee unlike the case in the Senate.

They also complained that there is so much disparity in the allowances of a senator and a member of the House of Representatives.

"But the Speaker explained that he had never voted any money for his office. He said he had been spending funds left by ex-Speaker Patricia Etteh.

Bankole told us that he was ready to defend every decision and money voted for his office. He denied smuggling or inserting any N60billion into the budget.

'The Speaker insisted that the legislative business had to change from what it used to be. He said there would now be benchmark for oversight functions."

Although most members were convinced of Bankole's transparency, those behind the plot are not giving up.

As at press time yesterday, it was gathered that those bankrolling the plot against Bankole had told their supporters to make the House ungovernable for the Speaker.

Another member said: "I think the grand plot is part of the build-up to the National Convention of the party. These party stalwarts want a divided National Assembly at the convention because they know that Bankole commands "large following.

He added: "You should know the arrowheads. Since he emerged as the Speaker, the opposing camp has not stopped planning against him.

Bankole's camp is believed to have launched a counter-move against the opposition.

A source in the camp said:

"We know their game-plan but we are proud that we have a capable and honest Speaker in Bankole. They cannot succeed."

The Special Adviser (Media) to the Speaker, Mr. Kayode Akinmade, said his boss had nothing to hide.

He said: "It is just a rumour and unfounded. Nevertheless, the Speaker, looking at the way he emerged is the people's Speaker. He has brought integrity, honour and dignity to the House.

"The leadership of the House saved the nation over N450billion unspent fund that was returned to treasury. This is unprecedented. The Nigerian budget, about 10 years ago, was equal to the money recovered and about 18 per cent of the current budget.

"I can say authoritatively that the Speaker is enjoying tremendous support from all members of the House. The allegations are unfounded."
