Two killed in Unizik road accident

TWO people were killed in a road accident that involved about 18 students of Nnamdi Azikiwe University(NAU), Awka, the Anambra State capital yesterday.

The accident when one of the school's buses that conveyed the students and a trailer rammed into each other at a junction of the school's Old Campus, Awka.

Those who lost their lives were the driver of the bus and a student.

About 11 of the students were injured. As of press time yesterday, five of them were on danger list at the Regina Caeli Hospital, Awka.

A source blamed the accident on men of the Federal Road Safety Corps (FRSC), whom, he said, pursued the trailer driver's to the junction.

But one of the FRSC officials at the scene of the accident, A.N. Amadi, denied the claim.

Other sources said the trailer driver lost control at the Independent National Electoral Commission's (INEC's) office on the Enugu-Onitsha Express on top speed, adding that no FRSC official was on its pursuit.

Death toll in deliverance stampede hits 20

■HE death toll at a deliverance session in Umuoluihe, Isiala Ngwa South Local Government Abia State, has risen to 20.

The session, which held in the countryhome of the late Mr. Martin Okereke Ihieukwumere - who also lost his life in the incident - was supposedly for the deliverance of the family from the grasp of demonic and satanic powers said to have inhabited the compound for over five years.

Speaking to The Nation at Umuoluihe, one of the survivors, Mr. Linus Abba, said he and others accompanied the zonal coordinator of a pentecostal church, the late Ihieukwumere, to the town for the session, which began at about 11p.m. last Friday and ended at about From Ugochukwu Eke, Umuahia 2a.m. the next day.

Abba said during the prayer session, he found himself using the toilet at intervals, and suddenly noticed a cloud of white smoke, adding: "That was all I could remember until I found myself in the hospital".

Also speaking, a man, who lost his wife and three children to the incident, said he was informed by his wife that they were attending the prayer session the previous night, only to hear of their death.

The deputy governor, Mr. Chris Akomas, said the government will not rest on its oars until the mystery surrounding the deaths was unravelled.

He spoke when he visited the survivors at Nneoma Hospital at Omoba where some of them were receiving treatment.

Akomas expressed concern that the church had not sympathised with the families of the victims.

He directed the Commissioners for Health and Environment to liase with the council chairman to furnigate the area so as to avoid an outbreak of epidemic.

Akomas praised the Medical Director of Nneoma Hospital, Dr Okey Uwah, for attending to the victims without demanding deposits, and said the government will offset the bills.

Responding, Uwah said all the victims were in of coma.

But two have regained consciousness and five have been referred to the Abia State University Teaching Hospital (ABSUTH), Aba, he added.

The Council Chairman, Mr. Anthony Agbazuere, described the incident as a tragedy, and made a N100,000 donation for the treatment of the victims.

Agbazuere advised residents to stay away from the scene of the incident for health reasons.

The traditional ruler of Alaoma community, Eze John Onwukwe, said the community was confused since the cause of the incident was yet to be ascertained.

He urged the government to provide security for lives and property of the residents. Deputy Commissioner of Police Ibrahim Maishanu said autopsy will be done on the bodies to ascertain the cause of their deaths.
