Delta chieftain in Kaduna Assassins kill Niger

OR the second time in one week, gunmen suspected to be assassins struck in Kaduna in the early hours of yesterday, killing a Kaduna-based-legal practitioner and a chieftain of the Niger Delta Peoples
Forum, Barrister Jimmy
Omogbereme.

The late Omogbereme, who was a strong member of the campaign team of the current National President of the Nigeria Bar Association, Jo<u>seph Dau</u>du, was killed at his No1 Jimmy Close, Angwar-Maisamari in the Malali area of Kaduna metropolis at about 1:45 am.

Recounting the ordeal of the late legal practitioner in the hands of his assailants, his wife, Mrs. Alice Jimmy Omogbereme said that the gun men came to the house late in the night, adding that they were woken up by the

barking of the dogs.

According to her,
"around 2:00am last night, I was woken up by the unusual barking of the dogs in the compound and I decided to call the security guard only to hear him shouting that armed robbers had visited us. From that moment, everything went silent only for me to start hearing them forcing the burglary proof of the windows open.

"And after about fifteen minutes, they moved into the sitting room and asked us to remain in the bedroom. I told my husband who asked us to keep cool and allow him handle the matter.

I took all the children and locked them up in the bathroom and from the bathroom, I heard a loud gunshot and began to panic. On their way out, one of them decided to come back and asked us to come out of the bathroom. I told them to assure us that they are not going to harm us which he ac-

cepted.
"When I came out, I saw my husband in the pool of his blood. I became frightened and pointed to one of the drawers in the room and asked the man who ordered us to come out to check there if he can find any gold there. Surprisingly, he left without v of the draw

ers to join his colleagues. "After sometime, I heard the voice of the security guard and asked him if they've gone and he said yes but quickly told me that they tied him to the bed.

"At about 2:30am, Operation Yaki people arrived in their van and moved into the house, untied the security guard and took my husband away, saying he was still unconscious and that they want to take him to the hospital for medical attention. But I overheard them telling our neighbor that it's like he was dead but they have to confirm from a medical doctor."

The security guard attached to the residence, Mr Peter Sumnoe, also recounted his ordeal saying that the killers who were five in number, forced their way into the expansive compound through the back From Tony Akowe, Kaduna

tectors on the fence."

According to him, "Around 1: 45 am, I heard an unusual noise and movement at the back of the compound. Because of the noise and the barking of our dogs, I decided to take a walk to the back of the premises," he

"Behold, three of the killers who were already in the compound, pointed a gun at me and threatened to shoot if I don't keep quiet because immediately I saw them, I started shouting to the main house that robbers have invaded the house.

"They asked me for the key to the main gate but I told

them it was not with me. They were furious and hit me hard with the butt of their gun. I fell down and pre-tended to be unconscious. They took me to the security room and tied me to the bed and I was blindfolded."

The state Commissioner of Police, Tambari Yabo Mohammed who confirmed the incident, said that it was rather too early for the police to make any statement regarding the killing.
The Police boss, who ar-

rived the scene of the incident as at exactly 10:47 am, described the development as a very sad one, but said that the police was already investigating the matter.

Reacting to the develop-





ment, the District Head of Malali/Badarawa, Alhaji Shehu Jae said he was directed by the Emir of Zauzzau, Alhaji Shehu Idris to visit the scene of the incident and report back to him Commenting on the incidence, Chairman of the Kaduna branch of the Nigerian Bar Association,

Muyiwa Olowokure asked security agents to fish out the killers, adding that the Police forensic department should be improved upon to make investigation into such incident easier.

While delivering a lecture on "Critical Issues during the weekend, Ohakim expressed
