# Naval Ratings torture businessman in Makurdi

IFTEEN Naval Ratings, on Friday night, man-handled a 33-year-old businessman, Anthony Okoh Ogbe, in Makurdi, the Benue State capital.

They also destroyed a high brow restaurant at HUDCO quarters.

Ogbe said he went to eat at a restaurant in HUDCO quarters at about 9pm, when the

incident occured.

He said: "When I got to the restaurant, I saw an old friend by the name Segun, whom I haven't seen in a long time.

"I greeted him, but he did not respond. He was sitting

with two other persons. I asked what the matter was, but he did not respond.

"At that point, one of those sitting with him said I should leave him alone. I told the man to mind his business that

Segun is my friend.
"Then the third person stood up and said, 'Do you know who you are talking to? I will teach you the lesson of your life today.'

"He made a phone call and Naval officers arrived in five taxis, armed with rifles, knives

and iron belts.
"They started beating up people in the restaurant. They destroyed drinks, food, plastic chairs and anything they could lay their hands on.

Some customers escaped without paying and a pregnant woman was kicked in the stomach. She slumped and was later taken to a nearby hospital.

"After identifying me, they tore my body with sharp knives, dragged me into the boot of my car and drove to their yard on Makurdi-Enugu road, opposite Power Holding Company of Nigeria

(PHCN) office.

"They dragged me out and continued to torture me. I fainted several times and they poured water on me to revive, only to continue.

"One of them tore my leg with a knife. He said he wanted me to bleed to death, but an officer came in and pleaded on my behalf. My friends came then and took me to the hospital."

Ogbe is recuperating in a private hospital.

The owner of the restaurant, Steven Kahemba Iorember, said the Naval Ratings were led by one Medola, whom he said was his regular customer.

Iorember said the violence has driven away his custom-

The victim's father, Aduku Ogbe, a retired State Security Service (SSS) officer, said: "I will do everything possible to bring those who attempted to kill my son to book.'

The Nigeria Bar Association (NBA), Makurdi branch, has taken up the matter.

It urged Governor Gabriel Suswam to expel the Navy from Security Council meetings and stop supporting it.

### Protest over removal of posters in Nasarawa

UPPORTERS of a Peoples Democratic Party ples Democratic Lary (PDP) governorship aspirant in Nasarawa State, Alhaji Tanko Al-Makura, yesterday protested at the Government House in Lafia, the state capital, over the planned re-moval of their candidate's campaign posters.

The protesters, who gathered at the campaign office in Almakura at 7am, also went to the palace of the Emir of Lafia, Alhaji Isa Agwai, whom they accused of collaborating with Governor Aliyu Doma to remove Al-Makura's bill-

The State Urban Development Board (NUDB) had in a letter on Monday ordered the removal of Almabaras's hill removal of Almakura's billboards.

The letter reads in part: "The NUDB is concerned about the way and manner your campaign organisation places billboards within the metropolis without seeking the board's approval.

"This is evident in the following locations: Opposite the Government House at Shendam road junction, Doma road roundabout, Investment House, and Jos road.

"You are required to remove all the billboards immediately and apply for approval from the board before further place-

"Failure to comply with the above will leave the board with no option but to remove them accordingly.

A statement signed by the monarchs read: "The traditional rulers in the 17 local government areas in Enugu State had, prior to this meeting, given Your Excellency our support for your re-election.

Igwe Ozobu said: "We are all aware of the struggle you put up for Nwodo's emergence as the PDP national chairman. It is quite regrettable that you're being paid back in this way. We urge you to be strong because we're behind you."

our modest accomplishments. On assumption, one of our priorities was to enthrone peace and open our arms to our brothers and sis-

"It's in this spirit that we welcomed back our brother and played our little role to support him, but the events of the past few weeks have been regrettable. "I've tried to refrain from commenting, but Nwodo's press interview on Monday is quite unfortunate.

"If his argument is that he acted because of the report from the Independent National Electoral Commission (INEC), why was it only in Enugu State that he purportedly unilaterally dissolved the executive through a press statement issued by his personal aide? "There were eight states involved in the INEC report, but only Enugu was said to be dissolved without consulting the National Working Committee. That decision remains ineffective because it was one man's deci-
