# Scores killed as JTF combs Borno for French hostages

AIDUGURI, the Borno State capital, was on the boil for much of yesterday in the aftermath of a deadly clash between suspected terrorists and men of the Joint Task Force, Operation Restore Or-

Scores of lives are believed to have been lost in the clash which might also have been a fallout of the massive search for a family of seven French tourists kidnapped by suspected Islamist militants in Cameroon four days ago and been brought into Ni-

Many houses suspected to be harbouring terrorists in Ummarari and Jajeri were set ablaze by the security agents.

This came some eight hours after a suspected suicide bomber detonated an

Maiduguri with Agency Report

Improvised Explosive Device (IED) on a JTF patrol vehicle on the Gamboru -Customs road of Maiduguri.

That incident provoked an exchange of gunfire between JTF men and terrorists.

The fire exchange claimed

All efforts to reach the spokesman for the JTF, Lieutenant Colonel Sagir Musa, proved abortive at press

There has been a surge in clashes lately between terrorists and the military in Maiduguri.

Security forces and western diplomats believe it could be an attempt by the terrorists to draw the military troops into conflict within the city and limit their search and rescue capability.

"There is a massive man-hunt ongoing," national po-lice spokesman, Frank Mba, told Reuters.

"Security operatives are working around the clock with search and surveillance to solve this.

The French hostages and kidnappers were near a small town called Dikwa at one point on Thursday, a Nigerian military source in Maiduguri said, asking not to be identified.

Dikwa is about 80 kilometres from Maiduguri and about the same distance to the border with Cameroon where the three adults and four children were taken hostage on Tuesday. French President Francois

Hollande said on Thursday the hostages had probably been separated.

French gendarmes backed by special forces arrived in northern Cameroon on Wednesday to help locate the family, a local governor and French defence ministry official said.

The abduction was the first The abduction was the first
case of foreigners being boko Haram blew up a customs office, destroyed roadseized in the mostly Muslim north of Cameroon, a former French colony, and highlighted the threat to French interests in West Africa since Paris deployed thousands of

troops to Mali to oust al Qaeda-linked Islamists who controlled the country's north.

On Sunday, seven foreigners were snatched from the compound of a Lebanese construction company, Setraco, in Bauchi State.

Many people were killed when suspected members of side stalls and engaged in gun-fights with the military on Thursday, three witnesses and a military source said.

'After the explosion, Boko Haram started sporadic shooting with rapid propelled guns leading to the death of many people," a commander in the military Joint Task Force told Reuters, asking not to be named.

Two corpses, believed to be those of militants, were outside a police station yesterday, witness Aminu Hakuri said.

Three people were killed on Wednesday when a bomb tar-geting the security forces exploded in central Maiduguri.

## EFCC arraigns seven Internet fraudsters

THE Economic and Fi nancial Crimes Com mission (EFCC) has arraigned seven internet fraud

All the suspects have been remanded in prison custody pending the beginning of their

The suspects are Philip Agbodobri (alias Daniel Karlssom) Peter Sunday (alias Richmon), Nnamdi Obinna, Amegor Ovenseri, Eloghosa Ocikiabor (alias Kristopher Kole), Osagie Aghedo Bliss and Idehen Obabueki Bleek.

The Head of Media and Publicity of the commission, Mr. Wilson Uwujaren, said the ac-cused persons pleaded not

guilty to the charges.
Philip Agbodobri (alias Daniel Karlssom), Peter Sunday (alias Richmon), Nnamdi Obinna, Amegor Ovenseri, Eloghosa Ocikiabor (alias Kristopher Kole), Osagie Aghedo Bliss, Idehen Obabueki Bleek, according to the EFCC " on or about the month of October, 2012 (and 18th day of January, 2013), at Siluko Road, Benin City within the jurisdiction of this honourable court did conspire amongst yourselves to commit felony to wit: obtaining

money by false pretence contrary to Section 8(a) of the Advance Fee Fraud and other Related Offences Act 2006 and punishable under section 1(3) of the said Act. "

Uwajaren said: " "In view of their plea, prosecuting counsel sought the leave of the court for a short date for trial.

"Justice Ajoku reserved ruling on their bail applications for February 27, 28, 29 and March 4; and adjourned to April 22, 25 and 29 for trials.

The court ordered that the suspects be remanded in prison custody."

The fraudsters are among the 20 suspected internet fraudsters arrested by men of the JTF, 4 Brigade, Nigerian Army, Benin and handed over to the EFCC, January 18th, 2013, for further investigation

and possible prosecution.

Twelve of them had earlier been arraigned before Justice A. M Liman on separate charges bordering on obtaining money by false pretence. They were subsequently granted bail.

At the point of arrest, the suspected fraudsters, who had in their possession forty five (45) laptops of different make, twenty eight (28) telephone sets, eight (8) internet mobile modems and one Nissan car with registration number USL 375 AG at the point of arrest includes: Idehen Obabueki, Adesa Lucky, Usuagu Uche, Eloghosa Olikiabor, Larry Edomwonyi, Amowie Maike, Francis Ezegbede, Itua Samuel and Endurance John Egbeifo. Others are Amegor Ovenseri, Iyen Ighodaro, Philip Agbodori, Lucky Robinson, Nnadi Obinna, Osabuohien Osahon, Chinenu Eze, Peter Sunday, Solomon Ogu, Niyi

Femi and Osagie Aghedo.
Meanwhile, Justice Dije
Abdu Aboki of the High Court of Kano State has convicted and sentenced two bankers, Funsho Olaleye and Ayoade Peter Abiola, to two years imprisonment with option of N410, 000 fine each.

The first accused was ordered to pay a compensation of N700, 000, while the second accused has already restituted the victim in the course of investigation.

The convicts, both former staff of Intercontinental Bank Plc (now Access Bank Plc) were arraigned by the Economic and Financial Crimes Commission on a six-count charge of conspiracy and misappropriation of funds.

#### Gunmen wipe out family of 12 at funeral wake for a grand

mother in Plateau State Lended in tragedy on Thursday with the death of 12 members of her family.

Gunmen suspected to be Fulani herdsmen stormed the venue at Kogom village in Vwang District of the Jos South Local Government Area and opened fire on relations and sympathisers who had gathered for the ceremony.

Two persons were injured. The gunmen seemed to have hidden nearby and waited for the wake to get underway before striking, sources said. They attacked with guns and

machetes. A relation of the deceased,

Habila Musa, put the number of the gunmen at 20. Musa himself narrowly es-

caped death. He said the invaders wore military uniforms and their

guns looked sophisticated. He said they struck at exactly 9pm and operated for an hour without challenge from

any security agency.
His words: "I escaped as soon as I heard sporadic gunshots.We began running in different directions. They did not pursue me, but they went after my younger ones and killed them mercilessly. They were pursuing them with torches and shooting at the same time".

drawal of the soldiers would ensure the return of peace to the state.

Spokesman for the STF, Captain Salisu Mustapha, was unavailable to speak on the in-

He was said to be out of the state on official assignment.

## ...five killed, seven injured in Gombe

**TUNMEN** yesterday killed five persons and injured seven others at the Bagadaza area of the Gombe metropolis in Gombe

Agency of Nigeria (NAN) that the gunmen came to the place and met the victims playing cards at about 4 p.m., adding that they started shooting, and in the process killed five instantly.

The source said that the injured, including a policeman attached to Government House, Gombe, had been taken to the Federal Medical Centre (FMC), Gombe for

treatment. When the NAN visited the hospital about 6.30 p.m., the injured were seen responding to treatment at the Accident and Emergency Unit of the hospital.

The incident drew the attention of scores of relations of the victims who trooped to the hospital of their their relations.

A wife to one of the injured persons, Mrs. Kate Philibus, told the NAN that she was called and informed that her husband had been shot and was at the FMC.

"I was not there. They called and informed me that he had been shot on the arm. and I am just arriving," she said.

A father to one of the survivors, Mr. Bulus Chiroma, told newsmen that her daughter who worked at a provision store in Gombe was lucky to

have entered a house when the gunmen arrived.

He said although his

daughter was also among the victims conveyed to the centre, she was, however, safe. A policeman told the NAN

on condition of anonymity that residents of the area stopped security personnel from conveying the corpses to their respective homes.

According to him, the people insisted that they must see either the Commissioner of Police or the governor of the state, Alhaji Ibrahim Dankwambo, before releasing the bodies.
Contacted, the Commis-

sioner of Police in the state, Mr. Mohammed Sule, confirmed the incident.

He said that he was wait-

ing for the details of the incident from the Divisional Police Officer (DPO) in charge of

the area.
"It is unfortunate, though I have not got the real details. It is in one slum. I am just returning and I have asked the DPO to come and tell me what happened," he said. Meanwhile, the police have

arrested one person in connection with the killings. The Police Public Relations

Officer (PPRO), Mr Fwaje Atajiri, said the suspect was arrested at the scene of the in-

Atajiri said that five persons were killed and seven others injured during the attack.

He said the suspect was being interrogated by the po-
