

## Confessions of an alleged serial killer

'How I murdered seven women'

Says I enjoy killing when the urge comes on me
'I killed my first victim in a Lagos hotel'



T was confession time yesterday for the man believed to have been responsible for the serial killing of young women in Port Harcourt over the last few months.

Thirty-nine year old Gracious David West told reporters in the Rivers State capital that he had also Killed in Lagos and Imo States. He put the number of his

victims at seven.

He was arrested on Thursday by the police while en route Uyo from Port Harcourt. His arrest came hours after

protests by women groups in Port Harcourt calling for the security agencies to fish out the brains behind the mysterious killings of

women in hotels.

West, who hails from

making love, I will bring out a kitchen knife and threaten her not to shout," West said. He added: "I don't know

West said he was on his
way to Akwa-Ibom when he what comes over me to kill.

After I have killed, I feel remorse and cry for killing, but after that, the irresistible

but after that, the irresistible urge to kill comes over me again. I kill alone.

"I was a member of the Degbam Cult group, I have since repented. I am not killing for any cult group. I just kill. I don't know what comes over me to kill.

I would steal their ATM

I would steal their ATM cards, empty their accounts: from any nearby ATM machine and move on. "It was not all the girls I slept with that I killed. I only killed whenever the irresistible urge to kill overwhelmed me. "I don't have a house. My mother died through

mother died through poisoning from her mate and I am homeless. I sleep in hotels."

He said that the phones he stole from his victims were sold to a customer in Waterlines Junction, off Port Harcourt/Aba Expressway and another buyer around MTN office by Oil Mill Market in Port Harcourt

West claimed to be an exmilitant rehabilitated by the Omega Power Ministry (OPM) which also got a job for him at the Federal University of Science and Technology, FUTO, Owerri, through the Church.

He ditched the job after stealing students' property.
Police Commissioner, Mustapha Dandaura who paraded the suspect does not believe that West was acting alone.

"The suspect is definitely not alone in these killings, though he had made useful confessions, but the command will go beyond his confessions to ensure that a conclusive end is achieved that serves the interest of instice."

that a conclusive end achieved that serves the interest of justice," he said.

Dandaura said his insistence that hotels in the state should install Closed Circuit Television Cameras, CCTVs, was beginning to yield positive

He vowed that the Police, under his Command would under his Command would fight crimes headlong in the state, adding that with joint operations with the amy and other security agencies, the killings in Ogoniland was dropping, while "I have stabilized East-West road, the Elele-Owerri road."

## Woman raises the alarm over son's safety

Adeyemi has raised the alarm over alleged harassment of her son by

suspected traditionalists.

She appealed to security operatives to save his son, Adekunle Adeyemi and his family from the clutch of

suspected traditionalists.
According to Oluyemisi, who resides in Bariga area of Lagos, some traditionalists in Omojoda (Odo Ayan) village had continued to threaten her son over his refusal to ascend a chieftaincy stool in the community.

community.

She said Adekunle, a computer engineer and pastor of a Pentecostal church, and his family now live in palpable fear of further attacks by the traditionalists.

She noted that the problem started in 2010 after her son was asked to accept the chieftaincy stool, following the unfortunate occurrences that have

occurrences that have characterised the reign of the current occupant of the stool. "When traditionalists in the village consulted their oracles,

it was learnt that the bad development in the town was because the current occupant was wrongfully installed as the traditional ruler of the community; hence their search for my son Adekunle whose reign they believed would improve the situation in the

"My son rejected the offer because of his Christian faith that goes against anything that has to do with tradition and the fact that his late father Lawrence Adeyemi had, before his demise in 1989 cautioned his children against the occupation of the chieftaincy stool of Omojoda because of the controversies that trailed the stool in the past, even as he warned of serious consequences against any erring

"The level of threat to the lives of my son, Adekunle, and members of his family and futile attempt by the suspected traditionalists to kidnap his wife and only daughter in 2018, forced them to relocate from forced them to relocate from their last residence in Ogun State to an unknown place. My worry is that despite their relocation, strange faces, and movements, continued to be noticeable at their former residence, heightening my fear that some people are still after them."

She disclosed that she recently received anonymous

recently received anonymous telephone calls from people Suspected to be kinsmen from Omojoda village, who during their conversations with her, vowed to deal with her son, should he refuse to accept the chieftaincy title. She added: "I am appealing to security outfits in the country

to come to my son's aid by warning those who are after his life, to please leave my son alone, as he could not accept the offer given him by his kinsmen."
