The governor pleaded with sympathizers particularly those who stood on the rubbles wailing and crying as the rescue work continued to come down from the top of the rubbles to allow the rescue team do the job quickly to enable them to save more lives.

Speaking on the owner of the building, Governor Tinubu said the person would be prosecuted. He said the developer is a criminal who cannot escape from justice having "had so many lives lost due to his stupidity."

"We know other places where this developer has this type of building. We would investigate him and the approved plan of those buildings he has built anywhere in Lagos," the governor promised the people.

Also speaking at the scene, the state command Police Public Relations officer, Mr. Olubode Ojajuni said the police rescue team responded swiftly to the distress call with all its personnel to assist in the operation.

He added that the large presence of anti-riot policemen at the scene was to forestall the break down of law and order by miscreants who could utilize the opportunity.
