PDP rejects planned interim govt

From SUNDAY ODE, Abuja HE ruling Peoples Demo-L cratic Party (PDP) yesterday expressed concern over the current clamour for an interim government to succeed the government of President Olusegun Obasanjo.

Rising from its National Working Committee (NWC) regular weekly meeting in Abuja, the party condemned the clamour and vowed that it would not accept anything short of a democratically elected government in 2007.

Accordingly, "the party urges all political parties, INEC and other relevant bodies concerned with the electoral process to put their acts together and commence in earnest the process of electioneering to ensure the realization of this democratic goal," a statement by the National Publicity Secretary, Mr. John Odey, said.



From RAYMOND TEDUNJAYE, Lagos NE of the leading gubernatorial aspirants in Lagos State on the platform of the Peoples Democratic Party

(PDP) Engr. Funsho Williams was yesterday murdered by suspected assassins in his resi-

dence at Dolphin Estate, Ikoyi. Though details of the incident were still sketchy as at press time, conflicting reports have however continue to trail how the dastardly act occurred.

While a source informed that he was strangulated to death,

it was gathered from another that the politician was killed in his bedroom by yet to be identified killers

From Front Page Col 6 man, who broke his silence in Abuja on the raging controversy, said the splinter group is the authentic PDP because of its disposition to what the party stands for.

He said there is no argument on the genuineness of the faction, as it is peopled by those that helped to produce President Olusegun Obasanjo during his first tenure in 1999.

Chief Lar, who was bed-ridden when the faction announced its emergence three months ago, described the Ahmadu Ali-led National Working Committee (NWC) as fake, just as he accused the NWC of penchant for disobeying court orders.

He said, "for any organization to be real, that organization must work according to the rule of law; that organization must respect court orders; when court gives a ruling, it is obeyed; then that organization is authentic. That organization also respects rights of human dignity; if you call on these, you are authentic. Anything short of that, you are not authentic. That is all!

"And all these people here, the lady and the gentlemen (pointing to Oyedokun and Safana) helped to produce the stution president during the first tenure. All these people here have, in the court asking an Abuja really been authentic."

deputy national chairman of the party. When you see people like this, then you know that they are the authentic PDP.

From Front Page Col 4 formed that he was shot to death by two strange gunmen who gained access into his bed-

Sources at his residence informed our correspondent that he was found dead in his bedroom at the early hours of yesterday by some members of his campaign team who had come to his house.

At the time of the incident. his police orderlies numbering four were said to be nowhere to be found, paving way for the killers to gain an easy access into the bedroom.

They were said to have surfaced two hours after the heinous act had been perpetrated.

It was also gathered that the late politician had attended a political meeting the previous night which dragged to 3 am before he retired to the bedroom.

Some members of his campaign team, who had come to visit him, were said to have been prevented from gaining access into his room by one of his aides, identified as Frank Ozugbuna on the excuse that the late politician was dressing up.

Williams' lifeless body was said to have been discovered by a female cook, who forced herself into the room for her master to come and have his breakfast, having waited patiently for hours.

But a member of the family, who spoke with our correspondent in an unstable mood,

said the politician was killed between 6 am to 10 am, "because his excellency just came in at about 3 am from PDP meeting".

"At about 8 am this morning, his cook came to call him that his food was ready, but one Frank a member of his campaign organization, said the cook should not worry and that Funsho is upstairs dressing up.

'After 30 minutes and he did not come down, we then decided to go up and see him. It is then we found his mutilated body in his bedroom," he narrated.

Unofficial report informed our correspondent that two of his police aides, two other private security aides and Frank Ozugbuna have been placed under arrest by the state Commissioner of Police, Mr. Emmanuel Adebayo, who visited the residence in company of other senior policemen.

Worried by the circumstances surrounding the death, chieftains of the party including family members prevented any member of the public including journalists to enter the premises, only the Commissioner of Police, Emmanuel Adebayo was allowed in.

Prior to his assassination, there had been series of attacks by political thugs in some of the rallies held last weekend in Lagos in which no fewer than four persons were shot dead.

Investigations revealed that the party's National Vice Chairman (South), Chief Olabode George, had to put off the rally that was to be held as a result of the incident.

Arrangement by his fellow politicians to move out the corpse into a waiting ambulance at exactly 3.50 pm was however halted following the large crowd of sympathizers at the residence.

Engineer Funsho Williams had on two occasions contested for the exalted seat in Lagos and lost with the latest being 2003 general elections which he contested on the platform of the party.

Meanwhile, the Advanced Congress of Democrats (ACD) condemned in very strong terms the brutal murder of Engr. Williams.

A statement by Chairman of the party's Media and Publicity Committee Lai Mohammed said the murder brought once again to the front burner the issue of politically motivated violence which has engulfed the nation in the last couple of months, especially the murder of Chief Jesse Aruku, the late gubernatorial aspirant of the ACD in Plateau State and the orgy of intra-party violence that changed the political landscape in Lagos State last week-

"This is not the kind of democracy we stand for," he said.

"At the Advanced Congress of Democrats, we are in contest and not in conflict with other political parties, and we believe that no level of disagreement, whether intra or inter-party should degenerate to the level of assassination," the statement said.

While commiserating with the family and political associates of late Engr. Williams, the ACD called on the Federal Government to ensure that assassination of Engr. Williams does not join the list of unresolved politically motivated murders in the land.

Also reacting to the incident, Lagos State Government yesterday offered a 10 million Naira reward to any individual, group, corporate body or institution that can provide information that can lead to the arrest of the killers of Engr. Williams, 13.1

state Governor, The Asiwaju, Bola Alimed Tinubu, who announced the reward in a reaction to the incident, also placed a two-week ban on political campaign in the state.

Stating that the police have been directed to dig thoroughly into the matter to unravel the perpetrators of the heinous crime, Tinubu vowed that his government would do everything possible to ensure that the state is not turned into a war zone for the spilling of blood for political purposes.
