MOTHER, DAUGHTER SUFFOCATED TO DEATH

A SIXTY-YEAR old mother, and her daughter, aged 28 were at the weekend in Etekwei community of Yenagoa town in Bayelsa State suffocated to death by fumes from a power generating set switched on at night following a power outage experienced for some days in some parts of the state.

Five other members of the family, however, remained unconscious for some hours before the rescue efforts of neighbours and treatment at the state Federal Medical Centre ensured their recovery.

New Nigerian in Yenagoa gathered that the incident, which occurred in the early hours of Friday, threw the town into mourning mood and nearly provoked violent protests by residents of the

community who claimed the failure of the state government to fulfil its promises on providing power caused such death from power generating set.

It was further gathered that the family of seven headed by the divorcee daughter switched on the power generating set around 10.00pm on Thursday night but later brought it into the living room to avoid its being stolen.

An evewitness, who spoke under condition of anonymity told our correspondent that the neighbours became worried on Friday when none of the occupants of the one room apartment were seen doing their usual early morning chores. It was at this stage that an alarm was raised and the door of the. room was pulled down and the unconscious bodies of the aged mother, Madam Elizabeth Tumugha and her daughter. Ms. Timipreve Tumugha with the grandchildren were discovered

While the five children were treated and regained consciousness, the aged mother and her daughter were confirmed dead by doctors at the Federal Medical Centre, Yenagoa, even as one of them was treated and discharged by the doctors.

Confirming the incident to our correspondent, the State Police Public Relations Officer, Ibokette Iniobong (DSP) said though the family of those affected had not reported the incident officially, the police deemed it fit to check out the report and discovered that it was true.
