Obi stated that Alkatex Nigeria Limited was registered in 1998 with RC number 334945 by the Corporate Affairs Commission, stressing that the particulars of the company were available at the commission for any body to verify.

He, however, explained that while it was true that ALKATEX as a company bid for, got pre-qualified, won and executed fully the contract for the supply of small part of voting cubicles to INEC, it did not in any way have any dealing either directly or indirectly with the person or office of the Senate President Senator Ken Nnamani.

"Our company has track record of quality service with all our numerous customers both public and private. Senator Ken Nnamani is neither a director nor/a shareholder in our company. Allegation that he is connected to our company is clearly false and unfounded," Mr. Obi said.

Accordingly, Alkatex Nigeria Limited said it viewed the misinformation in the Nigeria media as a calculated attempt to smear its good corporate image, thus demanded an unreserved apology from the erring media house. It also warned that failure to do so would compel the company to seek legal redress, just as it implored all well-meaning Nigerians to disregard any such insinuation in any quarters or in the media.

Sajo also said in the statement that the council had opened a condolence register at the Press Centre, Zuru Road, Sokoto to receive condolence messages from individuals and organizations from across the state.
