## Boko Haram: 500 PERSONS

IT is believed that about 500 people are so far known to have been killed in the recent battle between security forces and members of the Yusufiyya sect in Maiduguri, the Borno State capital recently.

Governor Ali Modu Sheriff announced the figure in Maiduguri during a meeting with a delegation from the state chapter of Christian Association of Nigeria (CAN).

He said the final figure of the dead which was being excepted from security agencies and religious bodies, would be incorporated in his report to President Umaru Musa Yar'Adua.

He said two bodies will soon

be set up to regulate the activities of Christian and Muslim clergy to forestall the reoccurrence of the just ended standoff in the state.

The governor frowned at what he termed as negative publications about the crisis, and urged people needing to write about the incident to visit Maiduguri, rather than sit down in far away places to produce inciting publications.

The governor sympathized with all the people who have lost their kith and kin as well as their property in the fourday chaos and appealed for patience and understanding.

In his response, Reverend Enoch Atiyaye of the Chapel of Grace praised the efforts taken to douse the situation, but called for constant vigilance to forestall future occurrence.

Meanwhile, the committee set up by the Borno State government to assess the damages and loss of lives caused by the recent crisis in the state capital says it has so far registered about two 2,000 victims.

The chairman of the committee, Dr. Bulama Mali Gubio while explaining thier findings to the Shehu of Borno said a greater percentage of the

victims were women and children made widows and orphans. He said assessment of property destroyed was still being collated and that they would be made public after a comprehensive aggregate had been compiled.

Dr. Gubio who is also the chairman of the Nigerian Red Cross said elder statesman, Dr. Shettima Ali Monguno had donated relief materials worth two million Naira for distribution to the victims identified.

Responding, the Shehu of Borno, Alhaji Abubakar Garbai Elkanemi urged members of the committee to sift through the entire town to identify all the losses incurred and give recommendation that could heal the wounds of the victims.

KATSINA State Governor, Alhaji Ibrahim Shehu Shema has observed that corruption retards all forms of progress in the society.

Justice Emmanuel Avoola announced the nomination of Governor Ibrahim Shema to serve as an honorary consultant to the local government integrity initiative for the useful advices he earlier gave to the commission.
