## Man, 27, killed over struggle for water

have locked the well barring neighbours from fetching water without giving any concrete reason for his action.

When the deceased intervened, it was gathered, an argument broke out between them which later turned into a fight.

It was learnt that few people who were around tried to separate them, just as Hamza was alleged to have gone into their compound, while the deceased opened the well for people around to fetch water.

"It started like a play but Hamza couldn't bear it. So, when we separated them, he went into their house. We all thought he had let go of the issue. So, he (Bashar), bent down and was busy watching

his stained body. Then, I saw Hamza coming out holding a knife in his hand and before I could ask Bashar to run, he stabbed him in the neck".

According to him, he was at the deceased's house to pick him to work when the incident occurred, adding that effort to provide first-aid to Bashar was not successful as blood kept rushing out of his body just as the deceased groaned, saying "take me to the hospital, take me to the hospital."

New Nigerian on Sunday also learnt that the victim died before reaching the hospital. The suspect, however, attempted to escape but people around over-powered him and got him arrested.

It was gathered that quick

intervention of the military task force in the area prevented other angry youth from lynching the suspect.

The father of the suspect who is an Islamic scholar in the area was apparently angry when the matter was reported to him and asked the youth in the community to kill his own son.

"It is not my saying but Allah's said he who kills should be killed; whoever removes someone's eye his eye too should be removed. The same thing is to happen to whoever removes somebody's ears or nose. This is Quran's judgment, not mine, and as a Muslim, the only thing that will give me rest of mind is to hear that Sharia law has been implemented on Hamza," he said.
