When the motion was put to vote by the Speaker, Honourable Aminu Tambuwal, who presided over the plenary, it was unanimously supported by members.

## Cult clash claims 3 in Lagos

VIOLENT clashes between factions of cult groups in Mushin area of Lagos State continued on Monday night, as two women and a baby were killed during a clash.

The baby, who was strapped on his mother's back, was reportedly hit by stray bullets from the rampaging hoodlums, who shot sporadically into diffent directions.

The situation created confusion and panic among residents of Sowunmi Street and Ewenla

Street, on the Isolo Road in Mushin.

A resident of the area who pleaded anonymity stated that activities of cult members in the area had become worrisome in recent times.

The resident stated that the problem started on Monday night, when a faction of the cult group invaded Sowunmi Street and started shooting sporadically.

The invading cult members reportedly met stiff resistance from the rival at Sowunmi area and a serious gun battle ensued.

The cult guys ran from

Sowunmi to Ewenla Street, shooting at each other and in the process shot two women and the baby.

The woman with a baby has since been identified as a daughter of one of the landlords in the area, whose mother reportedly took the corpse of the baby to Olosan Police station.

One of the victims of the mayhem was said to be a trader selling loaves of bread at Ewenla.

When contacted, the image maker in charge of the state police command, Ngozi Braide, claimed not to be aware of the incident.
