9 feared killed in Kwara, Anambra clashes

FOUR persons have been reportedly killed following a fresh clash between residents of Yaskira communityin the Baruten local govern-2 ment area of Kwara State and Fulani herdsmen in the town.

Also, the death toll in the on-going communal land dispute at the weekend, rose to five, following the killing of two more persons during a bloody that erupted early Sunday morning between Iruatu and Amansi villages of Ifite-Nteje community in

Oyi Local Government Area of Anambra State.

It was gathered that residents of Yaskira community allegedly killed three Fulanis in retaliation for the killing of a farmer said to be an indigene of the community.

The man, whose corpse was found on his farmland, had reportedly complained of incessant grazing of the farm by herds of cattle before his untimely death.

Sources close to the agrarian town told journalists in Ilorin on Monday that the deceased farmer had gone to his farm on the fateful only to see cattle that had always fed on his farm.

Some members of the community, who suspected that the act could not have been perpetrated by any other people except the herdsmen, descended on any Fulani herdsman on sight.

In an alleged retaliation, the Fulani herdsmen allegedly killed the farmer and dump his lifeless body on his farm.

The state Police Public Relations Officer (PPRO) Deputy Superintendent of

Police (DSP), Ajayi Okasanmi, who confirmed the killing, however, said that he was not sure of the number of the victims.

"I'm not too sure of the number of people that died. But the certain thing is that people died on both sides,"he said.

The police spokesperson also said that the Commissioner of Police, Mr. Olusola Amore had ordered a thorough investigation into the matter with a view to bring the culprits to book.

In Anambra, the bloody clash which was triggered off March 11, this year, fol-lowing the alleged sale of community land by some prominent men in the area, claimed three lives and left several others injured before the police took over the community and made some arrests.

But while the police occupied the two warring villages to forestall further bloodshed, the clash spread to Agwa village, Nteje in a reprisal attack which claimed the lives of two persons on Sunday morning at Orukabi, thus bringing the causality figure to five.
