

# Tragedy as man jumps into iron melting pot in Lagos

## 17-year-old electrocuted while working with stepfather

THE police in Lagos State have begun investigations into a suspected case of suicide by a contract staff member of an Ikorodu-based company.

This is just as 17-year-old boy was also electrocuted while helping his step-father with a scaffolding job at a building site at Alagbado area of the state.

An unnamed 25-year-old contract staff of the company reportedly jumped into the iron melting pot in a yet-to-be determined circumstance.

The state Police Public Relations Officer (PPRO), Benjamin Hundeyin, confirmed the incident to the *Nigerian Tribune*, just as he added that investigations had com-

menced.

Hundeyin said the incident was reported to the police by the safety officer in charge of the company.

He said "On August 3, at about 6:00p.m., the safety officer of a company at the Industrial Scheme, Odongunyan, Ikorodu, Lagos State reported that on the same day, at about 3:51p.m., a contract staff, 25 years of age, attached to AOD section of the scheme, ran to the iron melting pot, which is out of bound to all staff, during operation and jumped inside it."

He added that "All efforts made by his colleagues to stop him proved abortive and his body was completely melted and dissolved.

"Detectives visited the

scene of crime, while the family of the deceased had been contacted."

In a similar incident, an unnamed 17-year-old boy, who went to work with his stepfather was electrocuted at

Alagbado area of the state.

Hundeyin said the mother of the deceased reported at Alagbado police station that the boy was electrocuted while helping his step-father at a site.
