Onyeagucha who also queried why the resources of the south-south is being used to promote

It is however worrisome that a well that is barely 10 years old would cave in. Does it mean it had no reinforcement? Which engineer constructed that well?" Dr Emma Duru, a senior lecturer in the Rivers State University of Science and Technology and certified Nigerian civil engineer asked.

Another engineer with the Nigerian National Petroleum Corporation, NNPC, in collaborating Dr Duru's position, said that even at 10 years the well was too young to cave in if it had been properly constructed.

"Finally, the union condemns in strong terms, the parlous state of facilities in the university, particularly the decay in learning and teaching facilities and advises the Edo State government to honour the dead and injured students with a radical intervention in the decay in

the university," the union said.
