he people of Bonny in Bonny Local Government area of Rivers state are crying out for help over the remains of a rickety landing jetty situated at creek road which serve as the only recognized commercial take-off point from Port Harcourt to

The dilapidated jetty has been described as a death trap waiting patiently for who to consume. Regrettably, in spite the state of the jetty, repeated calls by the people of the area on the governor of the state, Rt. Hon. Chibuke Rotimi Amaechi, NDDC and relevant agencies to intervene and ameliorate the sufferings of thousands of people that flock the area daily to travel has continued to fall on deaf ears.

A notable politician who craved anonymity spoke to the, according to him "the problem why the jetty is still lingering is lack of unity; if the Bonny traditional institution, the highly placed Bonny politicians in government, elites and well meaning Bonny individuals including youths come together to including youths come together to demand for a new jetty it will be achieved. The polarity in the kingdom is stalling development and until such a time we decide to

move forward in the interest of progress and unity we might be in for more set backs.

According to an outspoken youth leader from the area who is also the Public Relations Officer of National Youth Council of Nigeria, NYCN rivers state chapter, Kingsley Adonis Pepple in his remark said, "efforts made in the past to change this situation were fruitless. I remember the last effort we made thru Bonny Island Foundation, we brought "Tori for Town" (a popular talk show in pidgin English) to make public our plight. I fear that a latent cause of this is the notion that our people ate the money originally earmarked for the project. |Another issue of note is that some of the leaders in Bonny all use Nigeria Liquefied Natural Gas, NLNG boat and as such, not even aware of what their followers suffer. Even as we cry for help, because they do not experience same; hence our plea falls on deaf ears. Our leaders are

Man Falls To Death From

Staff and various agencies occupying the Federal Secretariat Complex Port Harcourt, were amazed to find in the early hour of Tuesday October 9, that a man in his early 40's had taken a plunge from the eighth

The man identied as Mr. Amaewhule Lucky from nearby Rumukalgbor village is a landlord and was billed to remarry this Saturday. He lost his first wife to death, a close source revealed.

. The cause of his fall was not known as at press time but security personnel and food-peddlers and recharge cards sellers around the complex informed this publication that the deceased was not a staff of any of the ministries in the complex, they said an identity card discovered from his pocket showed him to be a staff of Total Filf

When this reporter visited the controller of works/housing in the complex, the official directed referred him to the controller Lands/Housing and Urban Development who explained he was not around when the incident took place. took place.

According to him, the Elekahia Police has taken over the matter.

He said such a tragedy has not happened in the over 30 years that the secretariat has been in Stories by James Galaxy Nornubari

The official said the incident took place very early, at about 08.00 hours in the morning when some staff were still on their way to the office and he has no knowledge of the man's name or his place of work since he was not present when the incident

The Land/Housing and Urban Development controller further advised staff and visitors to the complex to be watchful in order to avoid such disasters in future even as he suggested the erection of hand rails to avoid falls in future pointing out however, that the structural design of the complex might not go well with such an appendage.

The deceased was at the premises of the National Directorate of Employment, NDE on the 8<sup>th</sup> floor from where he crashed to the ground.

Sources said the NDE offices

were still closed at the time he fell. It is strongly believed he committed suicide although there was no evidence of a suicide note nor clear sign of what was ailing him. Accident

More confounding was the fact that there was the sum of about N50,000 in his pocket at the time the police came in to take his body

This definitely speaks of the depth of decay of commitment at the highest level of governance which further buttresses the point that our corruption on maintenance culture is at its peak to say the very least. considering the huge allocation[s] due the state each month, the Rivers people indeed deserve the best! Let the authorities learn to act right and promptly if service would remain the face of good governance perhaps like the present leadership in power

## Kidnapped Expatriate Found Dead Around Rivers State Governor's Town

n expatriate engineer kidnapped at Ipo village near Omagwa in Ikwere Local Government of Private State come weaks ago of Rivers State some weeks ago, is dead. His remains were according to sources from the area, found around the Rivers State governor's home town Ubima, close to Ozuaha village abandoned in a bus.

The Lebanese, a staff of JMS Int'l was kidnapped by unknown gunmen in Ipo village on September 24, 2012 and held until his corpse was discovered at

Ubima in a decomposed state in a bus left by the road side.

National Point was informed that security operatives had raided villages around Ipo, Omuagwa, Omuanwa all in Ikwerre in search of the abducted foreigner but barely few days after the search, his captors dumped his remain along the road.

The late site engineer, Makmound's body has been deposited at the Military Hospital, Port Harcourt while unconfirmed sources say his office is planning to invite a medical team to conduct an autopsy to ascertain the nature of his death.

A community member from the area told this publication that they were surprised when the security operatives stormed Omuanwa community in search of the kidnappers only to learn later that the kidnappers had shifted base a few days earlier. He accused the security of complicity.

"Who told them the security men were coming? When the search party came we discovered evidence of foreign food meaning

he was being kept around the area but they must have been warned to move", he said.

The kidnappers are still unknown but believed to be within Ikwerre communities.

Saddened by the death of the expatriate, security operatives in Rivers State have been flayed for failing to fish at the brains behind the wicked act.

Some are asking where the camera implanted by the state government to fight crime in the state is in the face of the daily security challenges in the state.
