and that. Ahmed, who is the son of the Chief Imam of Oke-Ayo Mosque Ibikunle Street in Osogbo, slumped during the imbroalio.

A neighbour of the deceased's, who spoke with our correspondent on Sunday, said Ahmed might have died out of exertion.

"When he slumped, there was nobody to come to his rescue. The violence was going on then. He had died before calm was restored," the neighbour said.

Kehinde was at the event to serve food and drinks to quests.

He was buried on Saturday soon after his death.

Meanwhile, the socio-po-Mitical organisation of Aregbesola, Oranmiyan, has urged the police to probe the alleged attack on the gubernatorial aspirant.

A statement by the Media Director of Oranmiyan, Mr. Gbenga Fayemiwo, urged the police to investigate the alleged attack on Aregbesola. But the Osun State Chair-

Cleric flays ING campaigners

The President of the Catholic Bishops Conference of Nigeria, Archbishop Alaba Job, has described those campaigning for an interim government after the President Oluseann Obasanjo on May 29, 2007 as enemies of Nigeria.

Job, who is also the archbishop of the Ibadan Archdiocese, warned that such people were also courting trouble for the country.

He spoke with newsmen in Ilorin on Saturday before the commencement of a mass held at the St. Josephs Catholic Cathedral, for the transfer of Ilorin Diocese from Kaduna ecclesiastical province to Ibadan ecclesiastical province.

The clergyman cautioned protagonists of interim government to stop and work towards the installation of a democratically elected govemment in 2007.

He said, "I do not know where those who speak of interim government got the idea from. It is not in our constitution. We are not in an emergency in the country. Why talking about interim government then?"

He said the nation's constitution was clear on the mode of succession and advised well-meaning Nigerians to discourage such proposal in the interest of the unity of the country.

He added, "And I urge you media practitioners not to en courage that (interim government). If you don't carry it on your radio and television, and people do not read it in the newspapers or on the Internet, nobody will hear such a ridiculous proposition."

Job, who decried the wave

of killings across the country, called on the law enforcement agents to check the trend.

"It makes my heart bleeds. Foreign readers of Nigerian newspapers on the Internet will be made to believe that Nigeria is not a safe place," he said.

It will be recalled that the emir had in September 2005, replaced three kingmakers - Alhaji Laaro Abdulkarim (Balogun Gambari), Alhaii Saka Aleshinloye (Baba Isale), and Alhaji Adio Alanamu,

(Balogun Alanamu).

He also appointed Alhaji Aremu Zubair as the Magaji Are to replace Alhaji Saadu Are, who had earlier been installed by the Idi-Ape community to succeed the late Alhaji Busari Alabi Alasa, the father of the former governor of Kwara state, Alhaji Mohammed Lawal.

The deposed high chiefs had in a petition to President Olusegun Obasanjo accused the emir of embezzling their monthly stipends over a period of about three years. He was also alleged
