In reprisal, the mansion of the Deputy President of the Senate, Alhaji Ibrahim Mantu was also burnt down

The policemen were in Jos to provide security cover for the eight members of the Plateau State House of Assembly, who had served an impeachment notice on Governor Joshua Darive.

## Plateau on fire as police kill 2

Attempts by the eight legislators on Friday to continue the impeachment proceedings led to a clash between the riot policemen and some protesting vouths.

Overwhelmed by the barricade, the riot policemen started firing tear gas and live bullets indiscriminately into the air.

But the vouths stuck to the blockade. When the riot policemen reached the gates of the Plateau State Specialist Hospital, some of them got down to remove the blockade on the road, while others were shooting on sight.

In the process, two people were gunned down instantly, while the third was riddled with bullets.

Angered by the attitude of the policemen, the vouths mobilised and went straight to the Jos country home of the Deputy Senate President. Alhaii Ibrahim Mantu, at 12. Mangu Road, and burnt down the whole edifice.

The house was being occupied by Mantu's elder sister. Ms. Abu Mantu. She escaped unhurt.

More than five cars in the residence were completely burnt, while three were smashed beyond repairs.

an Expedition Sport Utility Vehicle marked Lagos JB 797AAA amidst armed security provided by the EFCC.

He was applauded by those who had thronged the venue of the sitting for opening up the misconduct of the governor.

Earlier, the panel was inaugurated by the acting Chief Judge of the State, Justice Jide Aladejana, following the dissolution of the initial panel constituted by the Chief Judge of the State, Justice Kayode Bamisile. The new panel was inaugurated at about 8am inside the House of Assembly to forestall any clash at the venue.

Aladeiana said, "I have tried to consult widely among my colleagues and the National Judicial Council before I took the appointment."

An evewitness, Captain Ritrus Golen, told our correspondent that he and others had gone to visit Mantu's sister and as they sat to eat, a mob took over the house.

Golen said that immediately they saw the protesters coming, they closed the gate leading to the house, but the mob over overpowered the four unarmed policemen who were guarding the house.

"They got in and started spraying the house with petrol. They then set the whole edifice on fire." he added.

When our correspondent visited the scene, men of the State Fire Service Department were battling to out out the fire.

The governor visited the House of Assembly and the hospital to commiserate with the wounded.

Darive, who was visibly angry, told newsmen that the people of the state did not envisage the crisis in the state when they voted for democracy.

He said that he and members of the State Security Council had always protested against the use of live bullets on harmless youths.

While addressing the vouths. Darive asked them to remain quiet and resolute in the face of barefaced intimidation by operatives of the EFCC. Darive was accompanied by his Deputy, Chief Michael Botmang, the Gbong Gwom Jos, Dr. Victor Pam and the Secretary to the State Government, Mr. John Gobak.

In a separate broadcast to the people of the state on Friday. Darive further called on the Inspector-General of Police, Mr. Sunday Ehindero, to remove the state Commissioner of Police Mr. Ibivinka Kavode.

The governor accused Kayode of acting out a script to plunge the state into another round of blood letting in order to declare another state of emergency.

The governor, who called on the President. Chief Olusegun Obasanio. to intervene, described the actions of the EFCC as provocative

He decried the use of live bullets harmless vouths.

Meanwhile, the situation in Jos still remained tense as the police had beefed up security in the state. The protesting youths continued to set up bonfires along major streets in the metropolis and entry points into the city.

As at noon, shop owners hurriedly closed their shops while parents rushed to schools to pick their chil-

The Assistant Inspector General of Police in charge of Zone D. Mr. Declan Uzoma, had taken over the security from the State Commissioner of Police, Mr. Ibiyinka Kayode. Uzoma arrived in Jos last week

The house of the Minister of Industry, Mr. Fidelis Tapgun, located along Naraguta Avenue, was under watch as vouths try to set it ablaze. As at press time, the police were still battling to disperse the vouths, who had vowed to deal with all those perceived to be behind the recent crises in the state.
