The herbalist, an indigene of Opeji in the Odeda Local Government area of Ogun State, was arrested by members of the Odu'a Peoples Congress at Ijeun Titun area of Abeokuta.

The suspect, who had

been handed over to the police, was said to have exhumed the heads and some clothes at the cemetery of Saint John's Anglican Church, Igbehin.

The church has its burial ground near Paramount FM, on Abeokuta-Sagamu Road. Also arrested was a herb seller at Itoku market, identified as Afusat.

An OPC member, who pleaded anonymity, alleged that the suspect had been exhuming human heads from various cemeteries in Abeokuta for more than two years and he used to sell them to the herb seller.

The residents of the area, who were disturbed by the activities of the herbalist, were said to have reported him to the OPC, which kept him under the corrections of the area.

at 12am on Thursday, trailed him to the cemetery, where he exhumed three corpses, cut off

exhumed three corpses, cut off their heads, which he took away with clothes that were used in wrapping the corpses. The OPC members, who

were on his trail, arrested him as he was about to enter his house on Baale Street, Ijeun Titun, Abeokuta at dawn on Thursday.

At the state police headquarters, Eleweran, where he was being detained, Somorin confessed to journalists that he had been using human heads to prepare charms for his clients.

The herbalist explained that

the human heads were mainly for money-making rituals. When our correspondent

A young man impersonating as a lawyer has been sentenced to one-year imprisonment without an option of fine by a Magistrate's Court at the Murtala Muhammed International Airport, Ikeja, Lagos.
