Tension over killing of 80-year-old man

HERE is fresh tension in Biase Local Government between Biakpan and Etono 2 communities in Cross River State, over the killing of an 80-year-old

The new hostility is over boundary issues which led to the kidnap and killing of an 80-year-old man identified as Chief Kalu Etekpi.

Besides, a private property and a filling station belonging to the Brotherhood of the Cross and Stars have been destroyed.

A native of Akwa Ibom State, identified as Mr Paul Etim, who was also kidnapped on his way to Biakpan has, however, been released by his captors, according to a spokesman of the Biakpan community, Chief Kanu Ugo, on Friday.

But the Etono 2 natives have insisted that they have never launched any attack on the Biakpan people and have also accused the Biakpans of being responsible for the burning of their property and the

Our correspondent further learnt that the source of the problem was the urge by the Etono 2 people to communally own a land with their Biakpan neighours, an issue that had long been settled by the

the Biakpans.

He said before the resignation of Ali and other officials, caretaker committees would be constituted to run the affairs of the party pending the election of new leaders at state and national levels in November and December respectively.

Our source disclosed that the new arrangement was to satisfy some aggrieved party members who are insisting that the Ali team could not be trusted to conduct rancourfree congresses and convention.

Some of the aggrieved

members have reportedly told the Dr. Alex Ekwuemeled National Reconciliation Committee that they would only return to the PDP if Aliand his team resigned enmasse.

The source said the group insisted that the resignation of the officials at state and national levels would signal a clear break from the past and put the ruling party on the path of genuine reconciliation.

Ali had last week given indication that his team might leave office before December.
