Commander in Sango, Mr. Adeove Oyelola, told our correspondent that the driver of the vehicle had been charged to court. He told our correspondent that the police would not prosecute Ayotunde's father for the foiled attack but was "appealing to him. It is not easy to lose one's

child." He said he was not aware that the school had been shut, adding, "We gave them policemen vesterday (Thursday). I thought they reopened the school. I don't know why it was not opened today."
