of armed gang **T**robbers have ambushed and killed a Deputy Superintendent of Police and a constable at Obowo Local Government Area of Imo

The rampaging robbers also inflicted gunshot injuries on some other policemen, mostly inspectors and sergeants, who are now being treated in some unnamed hospital in Owerri, the Imo state capital

Our correspondent found that the slain DSP whose name was given simply as Joel by police sources, was the Divisional CrimeOfficer of the Obowo Police Division in the state.

It was learnt that the DSP had responded to a call that some robbers were operating at a location under the jurisdiction of the division at Obowo, by calling out a couple of his men to confront the hoodlums when he was felled by the robbers' bullets.

Deputy The Commissioner of Police in charge of Operations in the state, Mr. Goddy Okereke, confirmed the killing of the DSP and the constable on the telephone to correspondent on Wednesday.

Okereke denied the rumoured deaths of two inspectors of police in the state and described the incident as "unfortunate and very saddening."

In an exclusive interview with our correspondent in Asaba, the Delta State capital, Public Relations Officer, NSCDC, Mr. Egede Chukwudi Felix, disclosed that the boast of owning a boat or life command had been battling with the lack of necessary working materials and that this had hindered its efforts in fighting vandalism and other crimes.

He complained that in the 25 local government areas of Delta State, NSCDC had only three operational vehicles to work with.

He added that though the major activities of the command were in the riverine areas where illegal bunkering and pipeline vandalism frequently took place, the command could not

He said that the corps members could handicapped so much that they would resort to begging the assistance of ferries to help track down vandals but that such assistance was dangerous as the boat owners might either be collaborators with vandals or afraid of them.

He pointed out that NSCDC would record tremendous progress if all the stakeholders could provide them with enough transport facilities.

He said, "If we had our own

boats, it is a very easy thing. All we have to do is to lay an ambush for them. They get these products from the creeks around Bayelsa State and they transport them along the River Niger and when they get to the island, they discharge and sell.

"If we have enough transport facilities, life jackets and boats, then our activities will be enhanced."

Egede said that one of the major challenges of the NSCDC was combating heavily armed criminals with bare hands and hoped that this would soon be over as the recent amendments

to the NSCDC Act had empowered its members to carry arms.

The amendments. according to him, have also given them power to arrest and prosecute suspected vandals and their collaborators without handing them over to the police.

He said that in preparation for the members to carry arms and for the command to have ϵ standing armed squad, the authority had concluded plans to send them for further training at the Nigerian Defence Academy, Kaduna.

He said, "The Act has been amended to enable us bear arms, but we are waiting for the authorities to send us for training. They have plans to send us for training this year."

Boundary dispute claims 12 lives in Enugu

TO fewer than 12 persons were killed in a communa clash that broke out between Uwenu and Uwani clans in Akiyi Umulokpa community the headquarters of Uzouwani Local Government Area of Enugu State or Sunday.

The violence followed many years of boundary disputes and continued or Tuesday leading to the destruction of many houses and properties worth millions of naira.

It was learnt that the primary and secondary schools in the area were shut while many residents had flec to neighbouring towns as the killings persisted betwen the clans of the community.

correspondent Our gathered that rampaging youths of the two clans had continued to engage one another using dangerous weapons, including guns and machetes.

An eye-witness, one Chikezie said that there were mutilated bodies of some of the 12 victims in diffrent parts of the community.
