The deceased — Mr. Femi Falegan— and a former member of the Senate, Chief Festus Ola, were said to have been shot in Ibadan, Oyo State, on Wednesday night by gunmen suspected to be

Seven of the 13 other injured persons were shot on Thursday by men of the Joint Task Force in the Niger Delta, Operation Restore Hope.

The third incident was a free-

for-all at a meeting by the Osun State chapter of the Peoples Democratic Party in Iragbiji, Boripe Local Government Area of Osun State. Six people were wounded in the fracas.

Police sources told our correspondents on Thursday that the gunmen shot Falegan, a prominent businessman

Sources told our correspondents that Ola and Falegan were on their way home from a meeting with a village head whose father was on admission at the University

One of the sources said that the former senator was shot on his right leg while trying to revive Falegan, who was dying beside him. Ola was scheduled to meet

Adeojo, who is the party's secretary in the state, and the Chairman, Alhaji Ademola Rasagwas, were said to have

attended the meeting.

The protesting faction during the meeting alleged that Adeoio's faction had attempted

to undermine its interest.

It was gathered that Adeojo had attempted to explain his side of the case when some persons from the aggrieved faction booed him, leading to the free-for-all.
