## One dies, three injured as violence erupts over dogs in Ogere

ONE person has been reported dead and three others injured in Sunday's violent clash in Ogere, Ogun

to the area to restore peace. He said, "Kamal brought people who burnt the house (makeshift building) of Adepoju. After the fire, the body of one person, who was burnt beyond recognition, was discovered in the burnt structure."

The police spokesman added that the "prime suspect" (Kamal) would assist the investigations.

Adesanya, however. alleged that the clash occurred when a lady mobilised her

to avenge an attack on her by the dog sellers.

He said, "The clash was between the dog hunters and some people involved in the sale of Indian hemp in the

area. The dog hunter had

used their dogs to terrorise

people in the area on several occasions. "It was during the clash that the hunters set some structures on fire while a ladv. simply called Faith, was found to have been burnt in one of the houses."

Adesanya explained that the concessionaire had cleared some portions of land in Ogere, which would serve as alternative parking lots for the fuel trucks.
