Community demands \$500m compensation for oil spill

HE Ibeno Community in Akwa Ibom, has given the management of Mobil Producing Nigeria a two-week ultimatum to pay 500 million dollars compensation for damages caused by oil spills between February 2008 and December 2009, News Agency of Nigeria reports.

The MPN, an affiliate of the U.S. oil firm ExxonMobil, reported that a leak on a pipeline on Dec. 4, caused the discharge of unknown volume of crude oil into the Atlantic Ocean.

Subsequently, deposits of crude oil suspected to be from the Qua Iboe Oil Fields were noticed along the Atlantic shoreline in Ibeno, near Eket last

According to NAN, the oil firm, in a letter dated December 17, the Ibeno Clan Council, decried frequent oil spills at the Qua Iboe Oil Field and the resultant pollution of the environment.

The letter was signed by the Secretary to the council, Chief Herkings Inyang and the Speaker, Ibeno Council of Chiefs, Dr. Effiong Archiang.

It stated, "while we were condoling ourselves and trying to recover from the losses of the February 2008 oil spill, we are again confronted with yet another oil spill of great magnitude which occurred in the early days of December.

"It is obvious that the incessant occurrence of oil spills on our waters is a dangerous threat to our major source of livelihood, it also questions the sincerity of MPN in safeguarding our environment from avoidable pollution in the course of their operation."

The community also complained that it had suffered several times from pipeline failures and challenged the integrity of the pipeline network at the Qua Iboe Oil fields.

Police deny killing at Oshodi fracas

HE Lagos State Police I Command has denied responsibility for the death of a man during a fracas between two rival transport unions at Oshodi on Monday night.

command's The spokesman, Mr. Frank Mba, told the News Agency of Nigeria on Tuesday that the man could have died from injuries he sustained during the fight.

`Some persons were fighting at Oshodi and dangerous weapons, including guns and cutlasses, were freely used. How can people blame the police for the killing?" he said.

Mba did not confirm any arrest but said normalcy had been restored to the area.

Bauchi: Police arrest 20 suspects, security agents fear spread of violence

THE police on Tuesday said it has arrested 20 suspects in connection with the sectarian crisis that erupted in Bauchi metropolis on Monday.

Force Public Relations Officer, Mr. Emmanuel Ojukwu who announced the arrests in a statement explained that the crisis resulted from a disagreement between the leader of Kala-Kato sect, Mallam Badamasi and some of his former disciples.

Ojukwu's statement came on the heels of security reports that the crisis rocking Bauchi State may spread to Kaduna and Zaria if immediate proactive measures are not

The police spokesman said, "The timely intervention of the state command abruptly apprehended the situation from generating.

He said the police in its efforts to unravel the mystery behind the mayhem arrested 20 suspects, in whose possession two AK-47 rifles, bomb making explosive, 73 knives, gunpowder and some rounds of ammunition were recovered.

Ojukwu also said four houses were burnt during the crisis while 38 persons, including one soldier, who was until his death a member of the state security outfit, Operation

He said the police were able to rescue 16 captives from the enclave of Mallam Badamosi.

The statement added that the Inspector General of Police, Mr. Ogbonna Onovo, has put all the state commands of the police at red alert to forestall the spread of the crisis.

Our correspondent gathered that security reports prepared by some security agencies had indicated that the dreaded religious group popularly called the shites, have already started gathering in the two cities of Kaduna State.

Though our correspondent learnt that Bauchi is now calm, it was gathered that the regrouping of the shites in the neighbouring

state of Kaduna could be more devastated if not nib in the bud early enough.

A security source said, "Yes. it is true that the Bauchi State is boiling now. But what we have had in the state will amount to a child play to what will happen in Kaduna and Zaria if adequate actions are not taking

"As I speak with you now, the shites are regrouping in these two cities. The state government is aware of the threat, yet noting is being done about it.

"We need to be proactive in whatever we do and that is what

Cultism: Two die during initiation

WO youths in Ugep, Yakur Local Government Area of Cross River State have reportedly died during an initiation ceremony of an occultic fraternity in the state.

told our Sources correspondent that the two males were believed to have been murdered in a violent ceremony that was held for new members in Nkori-Nkpa axis of the council by the group on Sunday night.

When our correspondent visited the community on Monday morning, it was found that most people were still oblivious of the incident.

But there was palpable fear the afternoon when information about the activities of the cult group was circulated in the council area.

Sources from community said one of the corpses of the victims was picked up along the road and conveved to an undisclosed mortuary by the police.

The victim whose remains were said to have been deposited in the mortuary was identified as Igbor Igbor, 27, and only son of his parents.

Our correspondent gathered that the second victim was believed to have been buried in a concealed grave in the forest.

It was further learnt that the Chairman of the Council, Mr. Ubi Eta was agitated by the incident and had immediately ordered the police to unmask the identities of the perpetrators.

Already, it was gathered that the police were trailing one Mr. Item Obla, suspected to be the head of the group who was said to be at large.

Eta in an interview with our correspondent confirmed the incident and disclosed that the community vigilante group had arrested two suspected cultists in connection with the incident.

He said he was cooperating with the police to investigate the incidents adding that the council would no longer tolerate cultism.

Eta said he has not given up on the war against cultism declared earlier in the year by the state Governor, Mr. Liyel

The Governor had, in the heat of cult clashes during which many were killed in the state, inaugurated a programme to stem the tide of cultism.
