# Robbers kill army lieutenant after writing promotion exam

#### AC, PDP disagree over assassination plot

THE Osun Action Congress debunked assassination attempt claim by the Peoples Democratic Party, saying the ruling party was being mischievous.

Director of Publicity, Osun PDP, Mr Adeolu Adeyemo, on Friday, said that a member of the party, Olusegun Adegbite, who testified in favour of Olagunsoye Governor Oyinlola at the governorship Election Petition Tribunal. escaped assassination in Igbajo

An email by Adeyemo alleged that Adegbite was 'nearly assassinated' by some AC members in the town, on Wednesday, when Adegbite and some others were on a vigilance exercise.

Reacting, AC's Director of Research and Strategy, Mr Sunday Akere, described the allegation by PDP as laughable

Akere said, "It was the PDP that planned to kidnap our agent, Goke Esan, for stating in an interview with Sunday PUNCH that he was beside our slain party agent, Ayo Kemba Oni, when he was shot dead in Igbajo on April 14, 2007

"Since he granted the interview, Esan has been intimidated and hunted in Igbajo. We have reported the case to the traditional ruler of the town, Oba Olufemi Fasade. There was a grand plan by the PDP to kidnap Esan. Some people have been brought from Lagos by the PDP to do the job.

"The question to ask is – what was Adegbite and the other two PDP members masking as vigilance group members doing in the house of Esan at that time of the night? They wanted to kidnap Esan and he resisted them. That was what happened.'

Adeyemo said, "Before Olusegun Adegbite who was in company of two other vigilante members could know what was happening, his assailants had stripped him naked, beating him black and blue, while making frantic effort to set him ablaze.

## Fayose accuses Ekiti govt of burning LP's Secretariat

ORMER Governor of Ekiti State, Ayo Fayose on Sunday accused the government of being behind the burning of the Labour Party Secretariat in Ado-Ekiti by suspected political thugs.

The LP's Secretariat, a onestorey building along Iworoko Road in Ado-Ekiti and a watertanker belonging to Fayose were set on fire on Saturday by yet-to-be-identified persons.

While the state police command said its men were already investigating the incident, Fayose said the

investigators should not look far

for the culprits, saying Governor Segun Oni, who said he would have shot down his helicopter. was behind the burning.

But the government, in a statement by the Chief Press Secretary to Oni, Mr. Wale Ojo-Lanre, on Sunday, said that it was not known for criminal activities unlike the Fayose-era as governor of the state.

Ojo-Lanre said, "On his return from exile Fayose set a water tanker on fire just to get attention. We are therefore not bothered by the latest antics of

 'We are not like him' this political fugitive because we are not in his league.

"We are not in the league of a character, who ruled Ekiti State like a fiefdom, blackmailing, brutalising and assaulting all those he perceived as his poliltical enemies.'

But Fayose said the government burnt the LP Secretariat to Intimidate him. the Oni-led saying administration was jealous of his popularity even after abandoning the Peoples Democratic Party, on which platform he was elected governor in 2003.

He said, "Tell them that they cannot stop me no matter the intimidation, and I will not run away from this state. I know that some people are jealous of my popularity but it is too late to
