owning n Ч operating new motorcycle to earn a living, 21year-old Tobi Ogunleye has been gruesomely murdered. The deed was carried out by an envious Moroof Ganiyu, who lured him away from his house before killing him and stealing his commercial motorcycle in the Gbonoku area of Abeokuta, Ogun State.

Ogunleve would hardly have expected that death Boxing Day 2010 when his friend, Ganiyu, 25, also an operator of a commercial motorcycle, popularly called okada, pleaded with him to join him on a trip to Ibadan.

The dummy journey. however, turned out to be one of no return for the young okada rider as Ganiyu succeeded in carrying out his plot by killing Ogunleye. The suspected murderer confessed to the plot to steal Ogunleye's okada, which he said was new.

Before confessing to the crime, Ganiyu, who is to be arraigned in court immediately, had taken detectives at the Criminal Investigation Department of the Ogun State Police Command on a kamikaze trip by attempting to implicate an Ibadanbased herbalist, Tajudeen Akanji, of having a hand in the crime.

CRIME DIGEST learnt that the suspect had initially alleged that some traders in Sagamu


colluded with him to steal the motorcycle and also knew how the young Ogunleye disappeared, a lead that eventually proved to be critical in the case.

The disappearance of the 21-year-old okada rider had gone unnoticed, as his family thought he might have gone for the festive celebrations. When he was not seen at home three days later, another friend of the okada riders, who saw them before they commenced the ill-fated journey, raised the alarm.

It was learnt that Ganiyu had warned the friend not to tell anyone that he saw them together on their way to Ibadan on the fateful day.

CRIME DIGEST gathered that after relating conflicting

already decomposing.

In a bid to fill up the missing link he was trying to hide from the police, the suspect told another different story to the investigating team.

Ganiyu, who is being detained at the SCID, Eleweran, Abeokuta with Akanji, had earlier confessed that he kidnapped his friend, but claimed that he sold him with his motorcycle for N70,000 to Akanji, who had vehemently denied knowing about the case.

The 25-year-old suspect told CRIME DIGEST that he met Alfa (Akanji) in 2008 through one Hakeem Adeyemi, who is also now in police custody. "It was Hakeem that took me to the man; we live together in Ikorodu, where I work as a craftsman. I complained to him that I was not doing well in my trade, so he told me that he knew one Alfa in Abeokuta that helped him when he had the same problem and that since then he started doing well," he said.

Ganiyu alleged that Akanji swindled him of N400,000 at different times, saying this had informed his decision to implicate the Islamic cleric and Adeyemi in the disappearance of Ogunleye.

He narrated how he had received N40,000 from Alfa (Akanji) to abduct a girl, which he claimed the cleric killed and used money-making ritual. Akanji, however, denied killing the said girl, saying he lied that the girl had been killed in order to ensure that he collected money from Ganiyu.

Alfa, who denied most of the allegations, confirmed that he collected N400,000 from Ganiyu. "Hakeem (Adeyemi) is just a 'canvasser'; he brings customers and I do good luck charms for them, depending on the nature of how they want it. But I don't do moneymaking rituals or use people for it. I've never killed anyone in my life. I never kidnapped him in 2009, or called him in 2010 as he claimed and I never collected any boy with okada from him," he said.

Ganiyu, however confessed to the police that he decided to implicate Akanji and Adeyemi "so as to make them pay for swindling me of N400,000."

CRIME DIGEST learnt that though the suspect had confessed that the 'Sagamu traders,' who were earlier arrested and released, having thought to be innocent, were involved in the murder of Ogunleve. the accomplice had fled.

The state police commissioner, Mr. Musa Daura. confirmed the incident, saying Ganiyu would soon been arraigned in court.

information to the police to cover his deed, the suspect, who was said to have earlier contacted Akanji for money-making ritual, finally confessed to having killed Ogunleye in order to take over the deceased's okada.

After a thorough interrogation, the suspect confessed to having conspired with two persons at large to kill the young okada rider in order to inherit the late boy's motorcycle.

Police sources believed that the N50,000 found on the suspect after he killed his friend was the proceeds of the
