# Nigeria loses N80bn to bad roads annually – Investigation

NIGERIA is currently losing about N80bn annually due to the deplorable condition of her roads. A document prepared by the Federal Government has revealed that the country will need N35bn as the annual operating cost of keeping the roads in a good shape. According to the document, a total of N300bn is required to be spent over the next 10 years to bring the roads to a "satisfactory condition."



## Deaths, destruction trail Lagos savage floods

MID fears of further heavy Amily rears or residents on their their Monday took stock of their losses to Sunday's 15-hour downpour. And the figures are scary: several deaths, displaced thousands of persons, devastated homes and businesses, damaged vehicles, and blocked roads.

Four teenage girls and a baby-girl were found dead in a poorly-ventilated restaurant at Allen Avenue, Ikeja, where they had taken refuge from the rain and flood. In Aboru, Alimosho Local Government Area, two men and a woman were drowned. The Chairman of Onle Agege Local Council Development Area, Mr. Emmanuel Alagbe, said 11 children drowned in a canal in the area.

In many parts of the metropolis, vehicles and houses were submerged by the floods, while hundreds of houses collapsed under the weight of the persistent rain.

Our correspondents report that a section of the Lagos-Abeokuta Expressway has been rendered impassable after a stretch of the busy expressway caved in.

Governor Babatunde Fashola said on Monday that he would promptly write to President Goodluck Jonathan to take action on the road and to come to the aid of victims of the floods.

Fashola, who had on Sunday announced emergency holiday for school pupils and workers in the state, bemoaned the level of destruction while touring the metropolis on Monday.

"My sympathy goes to people, who lost their children, whether we can reach them or not. I condole with them. We have gone round the state, Obawole, Agege, Shomolu, Apapa, Akoka, Alagbado and Jakande to mention a few. Many people in the state have lost properties. We will be making an appeal to the Federal Government to help with funding to relocate and resettle them," Fashola said.

The National Emergency Management Agency has described the Lagos floods as 'incredible phenomena' and 'the most devastating so far' this year.

The Director-General of NEMA, Muhammad Sani-Sidi, said this during the first day onthe-spot assessment of some of the areas worst affected, according to a statement by the Shuaibu.

Sani-Sidi, who led a team of response agencies to Lagos, noted that a number of deaths had been recorded as well as the destruction of property. He said areas badly affected by the floods included Oshodi-Apapa Expressway, Ikorodu, Ojodu Berger/Isheri axis, Oworonsoki, Gbagada, Oniwaya/Agege, Iyana Ipaja and Lekki-Ajah.

Noting that the team would inspect the level of damage for necessary intervention by the Federal Government, he attributed the unprecedented flood to the length of rain, and heaviness blockage of water channels and drainages, indiscriminate dumping of refuse and the building of houses along channels.

Sani-Sidi called for interagency collaboration and coordination by the Federal Ministry of Environment, SEMAs. dam managers. fire service and construction engineers.

The team comprises security personnel, rescue officers, environmentalists and Red

One of our correspondents saw the corpse of a victim in Aboru. A resident of the area who spoke to THE PUNCH on the condition of anonymity, said the deceased was a butcher at the Abattoir Market and Lairage, Oko-Oba.

"He was a butcher at Abattoir in Oko Oba. His wife was just delivered of a baby about three days ago. As the rain started and flood began to enter into their apartment, the wife called to alert him. As he was coming, he noticed that the whole place had been flooded. He waded through the flooded. Maybe it was in the course of that the unexpected happened," the resident said.

Some residents of Agbelekale in Agbado-Oke Odo Local Council Development Area, recounted that they lost more than N10m worth of goods and property to the floods.

An advertising practitioner who is also a landlord in the area, Mr. Tope Awolaja, told our correspondent that he lost about N4m to the floods.

"Yesterday's downpour was a kind of tsunami in Agbelekale. We need serious government's intervention. People could not leave their homes because everywhere was flooded. Those whose houses were submerged had to climb telecoms mast or rooftops to escape being swept away by the floods," Awolaja said.

Some residents of Sari-Iganmu in Apapa-Iganmu Local Council Development Area have moved out of their homes en masse following the devastating effect of the floods on the area.

Some of the streets already deserted in the area include Adeolu, Okesanmi, Onakoya, Zion, Moshalasi and Afagbon.

It was also learnt that part of a storey building at 8, Moshalasi Lane collapsed on Sunday.

A resident of the area, Mr. Ayinde Bakare, said, "People have deserted the area. The movement started since Sunday. No house was spared in the area. We have never seen a thing like this. I took my family to Ajegunle and they are still there. Most families did not sleep in their houses, especially those who live in bungalows.

"Most residents became apprehensive when a part of the one-storey building collapsed. One of the room and parlour upstairs in the building just collapsed. Luckily, none of the occupants of the apartment was around when this happened.

"As I am talking to you now, you cannot see anybody on some streets. A lot of things were destroyed by the floods."

At Friesland Company, makers of Peak Milk, on Acme Road, Ikeja, the effect of the flood was devastating as the milk-producing firm has had to stop production.

#### Minimum wage: FG, Labour crisis meeting deadlocked, strike looms Fidelis Soriwei, Abuja

THE Federal Government and organised labour, on Monday, failed to reach agreement on the implementation of the new N18,000 minimum wage, raising fears of an imminent

industrial action in the country. The President of the Nigeria Labour Congress, Abdulwaheed Omar, and the President of the Trade Union Congress, Mr. Peter Esele, led labour leaders to the meeting where the Minister of Labour and Productivity, Chief Emeka Nwogu, and some top government officials represented the Federal Government.

After hours of inconclusive negotiations, the representatives of labour left

the meeting with a vow to execute their threat to go on strike. The NLC and TUC on

June 23 had given the Federal Government a twoweek ultimatum to ensure the implementation of the new minimum wage regime in the country. The ultimatum lapsed on July 8.

"We will go ahead with our arrangement for the strike since the Federeral Government

has shown its reluctance to implement the minimum wage law," a union official at the meeting told journalists.

Another meeting between labour and the Federal Government has, however, been scheduled for Wednesday.

At the meeting, which was also attended by the representatives of the Nigerian **Employers** Consultative Alliance, the government team proposed to pay the minimum wage only to officers from level one to six. However, the labour leaders insisted that the minimum wage must apply to all the cadres.

Although the meeting started on a cordial note with the usual exchange of views between the government and labour officials, a sharp disagreement later ensued over the pattern of implementation of the new

At a point in the negotiation, iournalists were asked to leave the meeting for the matter to be resolved behind closed door.

However, after about an hour of arguments between the government and labour, labour representatives stormed out of the meeting.

Leaders of the NLC and the TUC became agitated when the Chairman of the Salaries and Wages Commission, Mr. Richard Egbule, said that the new wage would not be accompanied by a salary review for all workers.

Egbule explained that the Federal Government would only apply the new wage to workers from level one to six as the FG had reviewed salaries of workers in 2010.

He was however opposed by the NLC President who insisted that previous increases in the minimum wage were accompanied by a relative review of the salaries of workers and same should apply to the present case.

Egbule said, "The increase in the minimum wage was not accompanied by any salary increase as was the case in the increases we have witnessed.

"Salaries were jerked up when the Federal Government increased the Minimum Wage to N5,500 and even went ahead to pay N7,000. So there has always been relativity. The Federal Government should preserve relativity and work through the marginal increase.

Esele however noted that there was no difference between the Federal Government and the states refusing to implement the new law.

The TUC boss who wondered why the Federal Government had not backed its purported readiness to implement the law with practical steps, criticised the government for calling for dialogue only when labour had issued threats to go on strike.

But Nwogu assured the workers that a circular for the payment of the new wage had been issued by the Salaries and Wages Commission which would make it impossible for workers to earn below N18,000.

He appealed to organised labour and other stakeholders to drop the strike option as a measure to resolve the minimum wage issue and urged labour to consider the security challenge facing the country and the implications of an industrial action on the nation's economy.

He also appealed to state governors to fast-track negotiations with labour to commence the payment of the new wage. Meanwhile, the NLC and

the TUC said they would hold crucial meetings of their NECs on Tuesday (today) and Friday respectively to take a decision on the planned industrial action.
