## LASU students protest hit-and-run killings

ome Lagos commuters and residents were on Friday held hostage at Anthony, Ikorodu Road, when the part-time students of the Lagos State Universit, Anthony Campus, went on the rampage to protest the death of an unidentified

The incident, which occurred at about 6 pm, took place on the Bus Rapid Transit lane in front of the campus by Idiroko Bus Stop. A police source told SATURDAY PUNCH that a commercial bus driver (danfo) on the BRT lane, had hit an okada rider carrying a passenger.

The source said, "A LASU part-time student was hit at this same spot just in front of the campus on Wednesday last week while trying to cross the BRT lane.

"A danfo driver, who was on top speed in an attempt to avoid the officials of the Lagos State Transport Management Authority, hit her and escaped.

The girl later died and that sparked a protest by her fellow students, which was eventually quelled by the police. Lots of danfo buses were damaged that day.

"This evening again, the same thing happened. danfo driver driving recklessly on the BRT lane hit an okada rider carrying a male passenger; the man was said to have died on the

"Although the man was not a LASU student, the students who witnessed the incident got angry and started a rampage, attacking every danfo bus in sight because the driver in question escaped again.

"It seemed they were reminded of last week's incident and the situation is not made any easier because there is no pedestrian bridge at that point. Right now, the traffic situation is chaotic on that route as the students are out on the streets watching out for any

danfo to destroy." Police **Public** The Relations Officer, Lagos Command, State

Jinadu, told SATURDAY PUNCH that the protest was as a result of last week's incident.

"A bus driver hit a LASU part-time student last week and that student was said to have died in the hospital

today. That is why her costudents took to the streets to protest her death.

"Police officers have been drafted to the scene and the situation is under control. No arrests have been made so far," Jinadu said.

## Revised Ondo laws take effect Sept 20 – Mimiko

overnor, Olusegun Mimiko of Ondo State on Friday presented to the public the newly-revised laws of the state.

Mimiko said the revised laws, which would replace the ones being used in the administration of justice since 1978, would become effective from September 20 this year.

He explained that the state now had 500 sets of revised laws published in a compendium.

He said the objective of the revision and publication of the laws was to remove obsolete and spent laws as well as codify the extant ones.

He said, "These revised

laws will further give an impetus to our aspirations to transform the social, economic and political landscape of the state just as it will regulate human behaviour and ensure peace

and order in the society. "Equal access to justice is an important pillar in the building of a stable and successful society, while its absence breeds myriad of societal vices such as the resort to selfhelp, violent crimes and a sense of hopelessness in the democratic order."

Mimiko urged institutions and stakeholders in the administration iustice system to partner and form synergies that would deepen democracy and ensure peace and security in the society.

The state Chief Judge, Justice Sehinde Kumuyi, lamented the stress being experienced by courts in the application of the obsolete laws.

He commended the state government for making the administration of justice easier with the revised

Attorney-General The and Commissioner for Justice, Mr. Eyitayo Jegede (SAN), enumerated the state government's feats in the justice sector since its inception.

He explained that the state government had put in place e-library services and a legal compendium software with automated internet updates for the bench and state counsel.
