How police killed retiring FRSC

THE THE Day Command Bayelsa of the Federal Road Safety Corps was on Wednesday thrown into grief after its official, Mr. Bassey Inoyo, was allegedly tortured to death by policemen.

It was learnt that Inoyo, senior FRSC official, was due to proceed on retirement leave in November.

An eyewitness told our correspondent that trouble started on Tuesday morning when a police officer from Anti-Robbery Special Squard Unit felt aggrieved over the conduct of a road safety official.

He said, "The road safety official who is serving in Sagbama Local Government Area of the state was blocked by a car. He was waiting for the car to be driven out before driving in. In the process, he temporarily blocked the narrow road.

"But the police officer who was in mufti hooted his horn many times signaling the road safety officer to clear the road for him to pass. Eventually, the road safety man drove in and parked but already the police officer

official in Bayelsa in mufti was aggrieved. He came down from his vehicle and descended on the road

safety official.' The source alleged that the policeman tore the FRSC official's rank and his uniform and then engaged him in a fight.

road safety Some officials were said to have rushed to the scene to assist their colleagues and in the process, the policeman, who drove in a private car was injured.

Our source, who pleaded anonymity, said, "The police officer phoned his office and complained that road safety officials were about to kill

SARS "About eight operatives went to the road safety office with guns and were shooting as if there was a civil war. They were also beating everybody they saw there to the extent that road safety men started pulling off their uniforms and running away. They fired teargas too."

The source added that Inoyo an elderly man, was apprehended by the

"The elderly man, the one that died today, could not run like others. They beat him until he fell down. They were stepping on his head with their boots. The head, the nose, the mouth, were all bleeding.

"They were beating him with the butt of the gun. When he fell down, they were dragging him on the ground like an animals SARS office. He died this morning. This is the height of callousness. I have never seen this type of thing before. This was an

evesore. The man they killed is due for retirement. He was supposed to retire February next year." he said.

said source Commissioner of Police. Chris Olakpe visited the office of the road safety and held a meeting with the sector commander.

When contacted, Olakpe, said the matter which occurred barely a month after the case of a prisons inspector, allegedly killed policemen had been resolved amicably between the two sister agencies.

During cross examination, Tahir, a police investigator attached to the EFCC, said the minutes of the 5th board meeting which approved the contract was fabricated.

The witness had told the court on May 15 that the contract awarded by UBEC to an American company "was against the rules."

The prosecution witness further explained that the contract was discussed 5th Governing at the Board Meeting of the Universal Basic Education based Commission misrepresentation.

The News Agency of Nigeria reports that the antigraft body is prosecuting four UBEC directors, an American contractor, Intermarket USA LLC and Intermarket Nigeria.

The accused persons are Molkat Mutfwang, Michael Aule, Andrew Ekpunobi, Alexander Cozma and Prof. Bridget Sokan,

They were said have deceived UBEC into awarding the contract to Inter-market, USA LLC and Alex Cozma.

About N636m was said to have been paid.

Earlier, Justice Abdul Kafarati, had held that the EFCC had established a case against the accused persons.

The judge adjourned the case till June 27.

Meanwhile, Universal Basic Education Commission is partnering the British Council to scale up teachers' training in Nigeria.

Executive Secretary of UBEC, Dr. Ahmed Modibbo said this on Wednesday while receiving an Interim Summary Report of the Evaluation of the Teaching Knowledge Test Essentials Methodology undertaken by the British Council.

Modibbo however said State Universal Basic Education Boards needed to be carried along, since they also have a role to play in scaling the programme.

Senate approves increase of FHC judge to 100

Senate ■ Wednesday increased the number of Federal High Court judges from 70 to

It also received the report of its Joint Committees on National Security and Intelligence, Defence and Army and Foreign Affairs on the investigation of the failed effort to rescue the abducted British and Italian nationals.

The increase in the number of judges followed an amendment to the Federal High Court Act of 2005

President of the Senate, David Mark, said the Senate would be available for further amendments should there be a request for an increase.

While some senators felt that the number should be 120, majority believed that there could be an abuse should the number be raised above the present

In his report, Chairman of the Senate Committee on Judiciary and Legal Matters, Umar Dahiru, explained that the FHC at the moment had 34 Divisions spread across the country and the FCT. Two new divisions were created for Kebbi and Taraba.
