He noted that fairness and the fear of God would also help him in executing his programmes in the state which he described as "the heart of the North.


The governor said, "I am convinced that with good intention and fear of God, you are going to serve well.'

Seven killed in Oyo, Jigawa crashes

O fewer than seven Nersons have been reportedly killed in auto crashes in Oyo and Jigawa states.

According to the News Agency of Nigeria, an accident, which occurred in the early hours of Thursday on the Lagos-**1**badan Expressway, claimed three lives and injured 12.

Meanwhile, persons were said to have Ogagaoghene, lost their lives in a canoe accident in Kirikasamma Local Government, Jigawa

A Lagos-bound Hiace bus coming from Osogbo, Osun State, was said to have Tost control in the front of Guru Maharaji village close to Ibadan, Oyo State, killing three persons.

Federal Road Safety Corps Sector Commander

four in the state, Mr. Godwin scene of the crash. who confirmed the incident, said the vehicle with plate number Lagos YB 65 MUS was conveying

15 passengers. Ogagaoghene said two male passengers and the driver died on the spot while two females and 10 males sustained injuries.

He attributed cause of the accident to "overspeeding".

"The corpses of those who died have been deposited at the University College Hospital morgue and relatives of the victims have been advised to go there to identify

their folks," he said. He said N360,275 belonging to the victims

The Jigawa accident was said to have occurred when a wooden canoe conveyingninepassengers capsized at Hadejia River after colliding with a bigger canoe moving in the opposite direction.

An eyewitness, Hadi Musa, said five persons were rescued by local divers, while the bodies of four others were discovered several hours after the accident.

Police Public Relations Officer in the state, Mr. Abdu Jinjiri, confirmed the incident.

Jinjiri said those killed included a threeyear-old boy, adding that investigation was still in progress to ascertain the cause of the crash.

Osogbo murder

A20-year-old, Adekola Adelugba, has been remanded in prison over the allegation that he killed a 22-year-old, Johnson Michael, during a carnival on Christmas Eve.

The charge sheet obtained by our correspondent on Thursday said the incident occurred at 1:00am on Eketedo Street, Osogbo, on December 24, 2012.

It said the accused person hit the Michael with a plank on the forehead during a freefor-all, which ensued at the carnival organised by Ekotedo youths to user in Christmas.

Police prosecutor, Mr Meret Wilson, told the Osogbo magistrate's court presided over by Magistrate Olusola Aluko, that Adelugba was guilty of conspiracy and murder.

Wilson said the offences "are contrary to, and punishable under Section 516and 316 (2) of the criminal code, Cap 34, Volume II, Laws of Osun State of Nigeria."
