30 die in Ogun pipeline explosion

killed about 30 people who went to siphon petroleum products from a ruptured Nigerian National Petroleum Corporation pipeline on Saturday.

It was learnt that the fire broke out after vandals started fighting over the oil. One of them was said to have fired a shot that that led to the explosion.

Operatives of the Inspector General of Police Special Task Force on Anti-Pipeline Vandalism Unit, Force Headquarters Annex, Lagos, who were on patrol were said to have gone to the scene to

avert further disaster. It was in the process that they arrested a medical doctor, Dr. Odusina Adegboyega, and one of the survivors, Sunday Reuben, on their way to the hospital.
