Police probe killing of constable by naval rating



▼HE Cross River State Police Command investigating the killing of a police constable, Sunday Agida, by a naval rating identified as

aga Affe, Calabar

Udoette Joseph. It was learnt that the rating stabbed Agida to death with bayonet after a heated argument with another person.

The incident occurred along Barracks road, Calabar. Narrating the incident to PUNCH Metro on Thursday, the pregnant wife of the deceased, Mercy, said there was no indication on the day that a minor car accident which happened in front of her shop, involving the vehicle of the naval rating and a lady could lead to the death of her husband last Sunday.

She said the accident degenerated into a heated argument between the naval rating and the unidentified lady, adding that her husband was not even at the scene when it occurred.

Mercy said, "When the accident between the naval rating and the lady happened at about 10pm, my husband wasn't around, but he was on his way to meet me in the shop so that we could go home together.

"After the accident, the navy man and the lady started claiming right of way and all efforts to get the matter settled by passersby proved abortive as the navy man became

aggressive. Even**tually,** Police came to the scene and took them to the station.

"Later, my husband came to the shop to pick me. This was around 11pm and I had closed my shop, but he (my husband) was talking with a friend who had come with him.

"Suddenly, the naval rating resurfaced and started harassing the man that was talking with my husband, saying he was among those who had earlier confronted him when the accident happened.

"But the accusation was false because my husband's friend strolled in with him. The accusation started another round of argument and as soon as my husband intervened, the navy man brought out a bayonet and stabbed my husband in the stomach.

"He wanted to run after doing that but passersby, including policemen, apprehended him. But all this did not help my husband as he was confirmed dead at an hospital about15 minutes later."

The state Police Public Relations Officer, Mr. John Umoh, confirmed the incident, saying it was already being investigated.

The Information Officer in charge of the Eastern Naval Command, Lieutenant Commander Way Olabisi, said the accused was indeed a naval rating who was spending his holiday in Calabar.

Olabisi said he would a patrol team from Akim not give details since the matter was being investigated police.

Truck crushes while on **▼RAGEDY** struck in front of Lafenwa Comprehensive High

School, Ota, Ogun State, last Thursday, when a 15year-old pupil, Miss Kemi Obanla, was crushed to death by a truck driver.

It was learnt that Kemi was killed while running errands for her class teacher.

It was alleged that the teacher had asked Kemi to go and buy cooked 'ofada' rice for her around 10am on the day.

An eyewitness, who craved anonymity, said the SS1 pupil was knocked down by a truck while crossing the road.

He said Kemi died while she was being rushed to the hospital.

"The girl was knocked down when she was crossing the road. After hitting her, the driver of the vehicle attempted to escape but the youths around apprehended him.

"It was when the girl was being taken to the hospital that she died. When we inquired where she was going at that time, we were told her teacher, whose name was not given, sent her to buy ofada rice for her."

The father of the deceased, Mr. Peter Obanla, said the death of his daughter, dealt a devastating blow to the family.

He said when the girl left their Ajegunle Close, off Mefun Road, Ota, home, she was full of life.

Obanla said about two hours after his daughter left for school, someone informed him that she was involved in a fatal accident.

He said, "The accident happened on Ahmaddiya Road, Ota. By the time I got there, I learnt that they had taken her to an hospital. She died on the way to the hospital.
