N8bn scam: Counsel asks judge to quit case

twist was L'Aintroduced to the N8bn Central Bank of Nigeria mutilated currency fraud suit on Friday when counsel for two of the accused persons, Olalekan Ojo, asked Justice Olayinka Faaji of the Federal High Court, Ibadan Division, Oyo State, to step down from the case, alleging that the judge had displayed a high level of bias against his clients in his earlier ruling on bail applications.

At the resumed hearing on Friday, Ojo said that with the reasons proffered by the judge on June 19, 2015 while denying the bail applications filed on behalf of his clients, the judge had already presumed the suspects guilty.

He therefore called on Justice Faaji to disqualify himself from the case which was instituted by the Economic and Financial Crimes Commission for another judge to take over.

A witness invited by the EFCC to testify against the staff of CBN and other banks involved in the case was not allowed to stand in the witness box because of the new development.

On June 19, Justice Faaji granted the bail applications of five accused persons and denied bail to 10 others. Mr.

Truck, bus collision kills 12 in Ogun

The victims were five females and seven males.

Some students of the Olabisi
Onabanjo University, Ago
Iwoye, were said to have died in
the crash.

Only one passenger survived the accident but sustained serious injury, and was rushed to the Olabisi Onabanjo University Teaching Hospital, Sagamu.

The corpses were said to have been deposited in a morgue also in Sagamu.

The driver of the truck was said to have driven against the traffic, and rammed into the bus, which was heading to Lagos.

The state police public relations officer, Muyiwa Adejobi, confirmed the accident.

He said, "We got a report from Sagamu that an accident
