On getting there, he took her to his friend's house and had his way with her.

"We suspect that the girl was drugged before he had the marathon sex with her. This was because when police operatives got there, they met a half-filled bottle of soft drink, with a chemical like sodium. We are trying to analyse the substance and the drink the girl took.'

Oti said the suspect's friend, who aided the crime, had also been arrested.

ESIDENTS of Ajegunle, Lagos State, demanded justice for the death of one Obinna, a salesman who was allegedly killed by a police stray bullet during a street fight in the area.

PUNCH Metro learnt that the police had been invited to disperse the fighters when the victim was hit by the bullet in a provisions store on Okoya

Our correspondents gathered that the street had been invaded by some hoodlums known as Cemetery boys, who were armed with machetes and

The men were reported to have attacked residents and used the opportunity to rob some residents and passersby.

Some residents of Okova were reported to have mobilised against the attack by hauling stones and broken bottles at the invaders

A friend of the late Obinna, Adams Isiaka, said he was with the 21-year-old when policemen from the Layeni division started shooting to disperse the warring parties.

He said the deceased had attempted to close the shop when he was fell by the stray

"During the invasion, the police were informed and they came to chase them away. In the process of chasing the hoodlums away, the policemen were attacked and the cops started shooting. 'In fact, if not for the timely intervention of Obinna's neighbour, who is a policeman, the treatment would not have started on time. The doctor, who attended to Obinna, just stitched the bullet hole without verifying if the bullet was still in him or not

"After his case worsened, we were forced to do an X-ray that revealed that the bullet was still lodged in his body. The bullet
