Finance director drowns in Abuja flood

A heavy flood on Friday swept away the Director of Finance, Federal Capital Territory High Court, Mr Tony

Okecheme was on his way to the Nnamdi Azikiwe International Airport in his official 2017 Toyota Camry when his vehicle stalled in the flood water at Galadimawa Roundabout, Abuja

Our correspondent gathered that Okecheme's car was following a Toyota Highlander which successfully navigated the flooded road.

His vehicle reportedly lost power and his attempts to restart the engine failed. He and his driver were said to have climbed on the car roof as the level of the water increased.

They reportedly spent a long time shouting for help but no one came to their assistance until Okecheme was swept away by the raging flood while his driver, whose name had yet to be ascertained, was rescued by some boys in the area.

Two young girls who claimed to be Okecheme's children were seen weeping uncontrollably at the scene of the incident.

The car which was filled with mud water was, however, pulled out by some people, who were angry over the alleged failure of the FCT Emergency Management Agency officials to rescue the victims in time.

Our correspondent observed the safety officers leaving the scene with an inflatable boat.

An eyewitness, Oyewole Adedigba, alleged that FEMA officials did not do enough to rescue the victims, adding that they were so nonchalant about the situation.

He said, "I was driving by when I saw the man and his

driver standing on the roof of their car in the middle of the flood, so I parked. I looked around to see if there was anyone that could help in rescuing them but no one was willing to go into the water. After about five minutes, the water rose to the chest level of the men.

"Then huge waves came and swept one of the men (the

director) away while some boys managed to rescue the driver. The FEMA agents were on the ground, but they were just standing around doing nothing.

One of those, who participated in the rescue effort, Abdul Rauf, said he was at home when someone told him that two men were trapped in the flood, adding that he visited the scene

the Non-Academic Staff Union on Friday handed the Federal Government a 14-day ultimatum to accede to some of its demands or face a nationwide strike.

The demands include the payment of earned allowances and the issue of sacked workers of staff schools.

Already, the non-teaching staff under the aegis of Joint Action Committee comprising the Non-Academic Staff Union of universities and educational institutions and the Senior Staff Association of Nigerian Universities, have directed all their branches to resume nationwide protests from Tuesday August 6, 2019.

The two unions, in a circular to all the branches after the JAC meeting held in Abuia, said that at the expiration of the 14day ultimatum, they would be left with no other option but to withdraw their services and shut down the universities if the Federal Government failed to address all their grievances,.
