## **Cultists kill two in Rivers community, 22 tricycles razed**

UNMEN suspected to The cultists have invaded the Kabangha community in the Khana Local Government Area of Rivers State, killed two persons and critically injured another.

One of the victims, identified as Blessing Nwinne, was killed on Easter Sunday, while the

had been harassing residents around the Mandara Mountains of Gwoza LGA.

"Although it has been long we had any confrontation with the insurgents, the incident of Sunday was commendable because our military fought with doggedness and commitment," he added.

Dennis Naku, Port Harcourt Second, Emeka Erasmus, had his hands severed by the assailants.

It was leant that the gunwielding cultists stormed the community just after dinner, shot indiscriminately in the air, went into the victim's compound and shot him several times in the neck to ensure he was dead.

It was also leant that another victim, who was shot by the cultists, survived and was rushed to hospital.

Though it was not clear if the attack was a reprisal, but sources said the gunshots sent the area into panic as villagers remained in their houses even at dawn.

The younger brother of the deceased, Kingston Nwinne, who conformed Blessing's killing to our correspondent on the telephone, said his brother was not a cultist.

"They came last night and my brother was not even feeling fine and was lying down. They shattered his neck with bullets. He was in a pool of his own blood. I reported the matter to the police and went to bury him," he stated.

Kingston called on the police to investigate the matter and fish out his brother's killers, adding, "He was not a cultist. He was not even making trouble."

In a separate development, about 22 tricycles were completely burnt during a fire outbreak at a mechanic workshop on the Eagle Cement Road, Iwofe in the Obio/Akpor Local Government Area of the state on Monday.

Our correspondent, who visited the scene, reports that wood and fabrication tools were

also razed.

Eyewitnesses said the fire was caused by persons engaging in illegal oil bunkering, popularly known as 'kpofire' in the area, even as they said fire fighters were not available to extinguish the inferno when it started around 2am.

One of the victims said, "They are doing kpofire (illegal bunkering) here. It's the kpofire that caused the fire; all our keke are burnt. We don't have anything again.

"The person doing the kpofire has fled. He has even packed out of his house. Now, I don't have anything with which to take care of my family."

Another resident, whose tricycle was burnt, said, "I don't know where I want to start from. It is the illegal petroleum business they are doing here that caused this fire."

On his part, the mechanic said, "My shop and the spare parts inside all got burnt. What I have lost here is above N12m."

The victims called on the state government to come to their aid.

Efforts to reach the spokesman for the state police command, Nnamdi Omoni, were unsuccessful as he did not take his calls or reply to a text message sent to his mobile telephone as of the time of filing this report.

## police rescue six kidnap victims in Delta

Toyota Sienna with number plate BWR 301 SU was under attack by hoodlums armed with AK-47 rifles at Okutolo on the Warri-Sapele Road.

"The hoodlums shot and injured the driver and a woman, while other passengers were dragged into the bush; the DPO swiftly mobilised patrol teams, assisted by the military patrol team, to the scene and they went after the kidnappers into the forest.

"They gave the kidnappers a hot chase; the hoodlums, who could no longer withstand the pressure, quickly abandoned the kidnapped victims and fled.

"The patrol teams successfully rescued the six kidnapped passengers, including Edoma Rita, Evelyn Chinwekwe, Believe Omoruyi, Linus Kojo and Idolo Christina."

He said one of the injured passengers, Esther Ojemudia, was rushed to the hospital, but she died while on admission.

The PPRO added that her corpse and that of the driver were deposited in a mortuary, while expended shells of 7.62 and 39mm ammunition were recovered from the scene.

He said the command had launched a manhunt for the hoodlums and appealed to members of the public to avail the police useful information that would lead to the arrest of the hoodlums.
