Family petitions police over 65-year-old father of 10's death

THE Gbantehu family of Onadilogun village, Ipokia Local Government Area of Ogun State, has petitioned the state Commissioner of Police, Edward Ajogun, over the murder of a 65-year-old father of 10, Whanse Gbantehu, by suspected grabbers.

The family alleged that some suspected land grabbers, who had been terrorising the community, had been sending threat messages to the family, warning them to stay away from the property.

The killing was said to have been the result of several threats and attacks on the family members and their properties.

According to the family, suspected thugs armed with cudgels, cutlasses and Dane guns stormed the deceased's house and allegedly killed him.

The petition, signed by the family solicitor, Chief Israel Talabi, daimed that 30 men were suspected to be involved in terrorising the community and the alleged murder of the farmer.

The family called for intervention of the police to prevent the suspects from engaging in serial killings.

The three page-petition read in part, "Our humble petition to the Ogun State legally constituted authorities of the Nigeria Police Force is to urgently intervene in this criminal murder, assassination.
