NE person was confirmed dead, while another escaped by a whisker when part of a residential building collapsed in Woii community, in the Obio/ Akpor Local Government Area of Rivers State.

Both the deceased and the injured were said to be carrying out reinforcement work on an apartment in the building when it caved in.

The property owner, Mr Ejike Ogbonda, blamed the incident on a flood which wreaked havoc in some parts of Port Harcourt and Obio/Akpor following hours of downpour on Tuesday.

Ejike expressed sadness that the man repairing his property lost his life.

He said, "Around 6am, my wife woke me from sleep and said water was coming in and that our gate was open. I have a drainage system that I personally constructed. From there you will see how the whole water from Woji, Ogborama and Apamini will flood my gate.

"It was moving towards the house, so I ran back into the house to wake my kids and we ran out. Everybody in the compound, including tenants, came out and tried to lock the gate against the flood.

"The thing was still coming in, so we got an engineer, who brought two workers. They were working on the building before that

thing happened. One is alive: the other one is dead."

Ejike said he rushed the victim to a hospital in his car and reported the matter to the police, adding policemen that accompanied him the hospital where the victim was confirmed dead and his remains deposited

in a morgue.

"We are begging the Rivers

State Government and the Obio/Akpor chairman to come to our aid; if not, this entire building will go down. Let them come and do proper drainage for us because this is a close," he added.

The Chairman of Obio/ Akpor LGA, George Ariolu, promised to carry out an onthe-spot assessment of the house.

He said, "For me to be adequate with my facts, I will take a visit to the scene

to look at what happened. But it is quite unfortunate and I sympathise with the owner of the said property. I also sympathise with the family of the person I heard lost his life."

The state Police Public Relations Officer, Nnamdi Omoni, said he was away for a programme but promised to find out about the incident and get back to our correspondent.

He had yet to do so as of the time of filing this report.

## Lagos task force impounds 410 motorcycles plying restrict
