

# Buhari, Zulum mourn general, 11 others killed in ISWAP ambush

Nigerian Army general, a major, a lieutenant and nine other soldiers were on Saturday killed in an attack by Islamic State West Africa. Province fighters in Askira town, in the Askira Uba Local Government Area of Borno State.

ambush while trying to provide reinforcement for the troops.

The attack, which began in the early hours of Saturday, was said to have lasted for several hours, leaving manusciell warden.

leaving many civilians dead.

According to sources, the ISWAP terrorists attacked the town, which is the hometown of Borno State House of Assembly deputy speaker, with 12 gun trucks, four of which were burnt down by troops of the Nigerian

military.

"They came to the town in 12

"They came to the town in 12 gun trucks and mounted them at strategic locations to give them an edge over the Nigerian forces," a source in Uba told to Sunday PUNCH.

Meanwhile, the Nigerian Army has confirmed the killing of Brigadier-General Dzarma Zirkushu in a fierce battle with terrorists of the Islamic State of West African Province ISWAP on Saturday.

Zirkushu was the commander

of 28 Task Force Brigade, Chibok. In a statement by the Director of

Army Public Relations, Brigadier General Onyema Nwachukwu, it said Zirkusu and the three soldiers paid the "supreme sacrifice in a very rare display of gallantry" in a counteroffensive against the terrorists.

It, however, said the troops

killed many members of ISWAP during the encounter in Askira, which borders Sambisa Forest.

ISWAP has been fighting against the Nigerian armed forces since it split from Boko Haram five years ago and pledged allegiance to the Islamic State.

The insurgents attacked Askira on Saturday morning with at least 12 gun trucks, setting houses and shops on fire and forcing some residents to scamper to safety, AFP reported.

In April, the army said a senior ISWAP commander, Bukar Gana Fitchmeram (aka Abu Aisha), and ritchmeram (ask Aou Alsna), and scores of his fighters, who were on a revenge mission at Damasak were killed as they attempted a reprisal following the killing of 12 high-value ISWAP commanders in the Mobbar Local Government Area of the state in a week-long air and ground operations by its

In September, it said its troops neutralised two ISWAP/ Boko Haram insurgents during a counter-attack against the terrorists who attempted to gain access into Babangida community in the Tarmuwa Local Government Area of Yobe State to

Government Area of Yobe State to loot to restock.

In October, it said troops of Joint Task Force North East Operation Hadin Kai deployed alongside Cameroonian Defence Force foiled an infiltration by terrorists on its camp at the Forward Operating Base, Wulgo, Borno, killing four members of rSWAP.

The President, in a statement by his Senior Special Assistant on Media and Publicity, Garba Shehu, titled 'President Buhari, nation mourn martyred general, said, "Nigeria has lost brave soldiers. I salute their courage. May their souls rest In peace. General Zirkusu leaves us sad and devastated. The soldier in him will remain immortal. I pray to the Almighty to give you and the bereaved families the strength and courage to bear this

On his part, Zulum commended the Nigerian military for its resilience in a battle with

the terrorist group.

In a statement by his spokesman, Malam Isa Gusau, the spokesman, Malam is a Gusau, ine governor while commiserating with with the military over the loss of some military officers, thanked the fallen heroes for what he called "their supreme sacrifices to the Nigerian Nation," adding that "the people of Borno adding that the people of Bolino
will remain forever grateful to
them and all fallen heroes, and
will remain fully supported of
gallant troops currently operating
in front lines".

The governor also commiserated with the residents affected by the attack.

"Today's unfortunate incident in Askira Uba Local Government Area reminds us that while our military, other armed forces, volunteers and all stakeholders make combined severe efforts

towards peace-building; while many insurgents surrender their arms to toe the path of peace and while reclaimed communities witness return of peace and access to livelihoods, some insurgents

are hell-bent on ensuring we do

not fully regain peace.
"The goal of these categories of insurgents should challenge us to remain focused and ceaselessly commit ourselves to support our

troops in many ways, particularly with logistics on the part of the government, and with credible information and prayers on the part of all of us as people of Borno State."

## Zamfara APC holds parallel congresses

The Zamfara State chapter of the All Progressive Congress has conducted a parallel congress in the state.

The national headquarters of the party had sent delegates, under the chairmanship of Ibrahim Kabir the chairmanship of idramin Kabii Masari, to conduct a congress in the state after it was rescheduled several times due to lingering crises between Governor Bello crises between Governor Bell Matawalle and Yari's supporters.

Addressing members of the party at Government House

Gusau before the commencement of the congress, Masari said, "the national headquarters of the party

national headquarters of the party has approved the conduct of the congress in Zamfara state."

Masari said the congress was approved by the national headquarters of the party, stressing that it did not violate the constitutional provision of the native.

"We are in the state to organise the congress based on our party's constitution. I am calling on all members to respect the party and join the congress".

Masari also warned that the

masari asso warned that the party would not recognise any parallel elections apart from the one he was sent to supervise.
"I am calling on all members of our great party to participate in the congress if they want to be recognised as bona fide members of the party. Anybody who fails to participate in this congress is

not loyal to APC and is not its member," he added. Marafa, through his

spokesperson, Alhaji Bello Bakyaauwa, said the congress conducted by his faction was

He said, "Today (Saturday), we have successfully conducted our ward congress into 147 elected ward chairmanship positions across the state. This congress was conducted parallel with the Governor Matawalle-led faction of

"We truly appreciate

concern and commitment to APC Marafa/Yari's faction of Zamfara state. I also wish to state that the elected excos of Marafa/Yari's faction are bona fide members of APC. We will not accept any ward leaders of the party arising from the faction of Governor Matawalle because we are fully convinced that no congress was democratically conducted on their part".

Still dissatisfied with the arrangements, Yari had urged his supporters not to participate in

In a letter signed by the Publicity Secretary of the Yari APC faction, Alhaji Ibrahim Magaji, the former governor called on his supporters to boycott the congresses because of a pending court case.

It read in part, "We will not participate in the congress because there is a pending court's action

### Pay special constables salary, PCRC begs community leaders

HE Police Community Relations Committee in Ogun State has appealed to community leaders to take up the responsibility of paying the salary and other remunerations of the special constables deployed for

community policing in the state.

The State Chairman, PCRC,
Chief Samson Popoola, who made the appeal at the investiture of High Chief Olumide Aderinokun High Chief Olumide Aderinokun as the Ogun State PCRC patron, said community policing was a

volunteer job.

The Force Public Relations
Officer, Frank Mba, had said that the Nigeria Police Force would not be placed on a salary but would be given stipends.

However, Popoola urged community leaders in the state to encourage the volunteers with the payment of salary as part of efforts to support the fight against

insecurity.

He explained that the special onstables were given police niforms to confirm identities by

the government.

Popoola, however, urged community leaders to support security agencies to fight insecurity

in the state.

He said, "It is very clear from the beginning that police constabularies are supposed to be volunteers. That is why those

people that are recruited must be gainfully employed. They will only give their time and they are supposed to work within their communities.

policing; it is not as if we are recruiting policemen but we want nunity people to be engaged and to be part of that comm
