Uduak's husband, Femi, while lamenting the death of his wife, said the armed robbers operated at two other locations in the area.

The auditor explained that the police had yet to track down the suspects, adding that ther gunmen, after carting away his wife's property including her phones, withdrew N100,000 from her bank account.

The 40-year-old added, "I just returned home when neighbours from my wife's shop came to my house to inform me that she was shot by armed robbers. They said she had been taken to the Randle General Hospital and I quickly rushed there but met her dead.

"Three armed robbers did the operation; one of them was on the motorcycle while the two other robbers got down to rob her, as she was alone at the shop. She was shot in the

process and she died at 9.17pm on January 30, 2022. Her corpse has been deposited in a mortuary.
