Village head, 14 others die in fresh Kaduna attack

THE newly-installed Head of Kakura Community in Chikun Local Government Area of Kaduna State, Isiaku Madaki, was on Sunday murdered by yet-to-beidentified gunmen.

The PUNCH gathered that Madaki's murder sparked off a reprisal attack on a Fulani settlement in the area where 14 others were feared dead.

A resident who identified himself as Baban David disclosed that deceased was installed as the community head on Saturday.

He said, "We all gathered in his residence earlier in the day (Saturday) to rejoice with him over his appointment. We were shocked when in the early hours of the today (Sunday), we began to hear gunshots.

We were afraid and could not come out of our houses. Later, we were told that the gunmen had killed him in the presence of his wife and family.

We found his dead body lying on the ground. His wife told us the gunmen broke into their residence and shot him. They did not take anything, neither did they abduct anybody."

On his part, Mallam Buhari explained that early in the morning, the natives surrounded the Fulani settlement and asked them to leave the area, describing them as "hypocrites."

Buhari said while they were leaving the area, they were attacked and some of them killed.

"On our way out of the village, we counted four corpses. Later on the bush path they were the death bodies of ten others littered on the ground," he added.

Meanwhile, policemen were said to have been deployed in the community to maintain law and order.

Even as normalcy had returned to the community, most residents had fled the area for fear of the unknown.

Gunmen invade Plateau communities, many feared dead

CORROW and anguish Oon Sunday enveloped the people of Kanam Local Government Area of Plateau State following the invasion of their communities by gunmen suspected to be terrorists.

The Chairman of the

National Union of Road Transport Workers in the local government, Alhaji Nuhu, who confirmed the attacks told The PUNCH that in one of the villages in Gyanbahu community, six people were killed by gunmen who also set several houses on fire.

He said, "It was around

12pm today (Sunday) that the attacks on the villages in Kanam started. Some gunmen numbering about 200 came on motorcycles and attacked about three villages, killing anyone they saw and setting their houses on fire.

"In Gyanbahu village, about six persons were killed by the

gunmen. Before attacking Gyanbahu, they first attacked Kukawa village and burnt down several houses and nobody knows the number of people killed because people were just running to escape."

The NURTW official also

alleged that the suspected terrorists came neighbouring Taraba State to raid communities in Kanam.

According to him, many of the people who escaped being killed are currently taking refuge in Dengi, the Council Headquarters.

"As I am talking to you, the gunmen are now heading towards Garga village. We just escaped from where we are to Dengi town," he added.

The official described the plight of the people as pathetic and called on the government and security agents to intervene in the situation and stop the terrorists from attacking more villages.

Kanu's lawyer faults secret trial of terrorism cases

Alegal practitioner, Aloy Ejimakor, has picked holes in the new practice directions on terrorism trials recently issued by the Chief Judge of the Federal High Court.

Ejimakor, one of the defending lawyers detained leader the People of Indigenous Biafra, Nnamdi Kanu, on the treasonable felony and levied terrorism charges against him by the Federal Government, described the new practice directions as unconstitutional, noting that it violated Section 36 of the Constitution, which requires all trials to be in public.

In a statement on Sunday, the lawyer explained that subsection (3) of Section 36 of the Constitution stated that "The proceedings of a court or the proceedings of any tribunal relating to the matters mentioned in subsection (1) of this (including announcement decisions of the court or tribunal) shall be held in public.

The second is subsection (4) of Section 36 of the Constitution which states that, 'Whenever any person is charged with a criminal offence, he shall, unless the charge is withdrawn, be entitled to a fair hearing in public within a reasonable time by a court or tribunal.'

He added, "The only

restrictions the Constitution allows is on a case-bycase basis and it must be narrowly-tailored by the particular court or tribunal before whom the suspect is being tried, not by an omnibus Practice Directions that seeks to envelope every case in one fell swoop.

narrowly-"The first narrowly-tailored exception can found at Section 36, subsection 4(a) of the Constitution which states that "A court or

such a tribunal may exclude from its proceedings persons other than the parties thereto or their legal practitioners in the interest of defence, public safety, public order, public morality, the welfare of persons who have not attained the age of eighteen years, the protection of the private lives of the parties or to such extent as it may consider necessary by reason of special circumstances in which publicity would be contrary to the interests of justice.
