A source said the lovers were suddenly ran out to call for help. He added that when some

motel workers rushed into the room, they found Lamidi lying motionless on the ground.

"The girl said the man wanted to enter the toilet but slumped and fell on the ground. A doctor that works in a hospital close to the motel was called and when the doctor got to the room, he certified the man dead.

The girl said she came to Lagos to meet the man as he promised to marry her; she came with some property and had the intention of moving into his house to be his live-in lover. Instead of going to the man's house, they went to the hotel and they were in the room when the girl ran out to call for help because the man slumped.

"So, when people rushed into the room, they found him lying unconscious on the ground. The incident happened around 8.40am on Sunday but the girl arrived from another state on Saturday. The girl said she met the man online and that they had been chatting," the source added.

The corpse was taken to a mortuary, while the woman was arrested for interrogation.

The state Police Public Relations Officer, SP Benjamin Hundeyin, who confirmed the incident, said the suspect declined to involve her parents in the investigation.

He said, "We have contacted the deceased's family and they

Tenant sues landlord over poor facility, demands refund

tenant, Raheem Olabanji, has filed a letter of demand against his landlord. Johnny Rowuru, before the Yaba Magistrate's Court over his refusal to refund his rent and commission fees paid for an office space in the Lekki area of Lagos State.

Olabanji's counsel, Olusola Okuwobi, said his client paid N600,000 to the landlord and N140,000 to the agent as directed by the landlord.

landlord did not fix basic amenities in the office space, which made Olabanii decide to leave four months later.

The claimant therefore sought the refund of the N740,000.
