Three suspected robbers killed in Delta

Command have killed three suspected robbers.

The state police spokesman, DSP Bright Edafe, who confirmed this to City Round in Asaba, stated that the command also recovered a pumpaction gun and six live cartridges in an abandoned bag.

He said, "On Thursday, June 22, 2023, operatives attached to the B' Division, Warri, led by the DPO, SP Bolarinwa Alabi, acted on a distress call about an armed robbery operation along Ugborikoko/Giwa-Amu Airport Road.

"The hoodlums were operating in an unregistered black Toyota Corolla car; the team went to the scene and when the hoodlums sighted the police team, they fired gunshots at the policemen and the team retaliated.


"They engaged them in a serious gun duel during which three of the hoodlums were fatally wounded, while other members of the gang escaped with bullet injuries."

Edafe said the injured suspects gave up the ghost while being taken to a hospital.

He said items recovered from them included one cut-to-size locally fabricated gun, two live cartridges, an unregistered black Toyota Corolla car, and eight different vehicle keys.

In another development, Edafe said the command recovered one pumpaction gun and six live cartridges in an abandoned bag.

According to Edafe, operatives of the Rapid Response Squad, while on a visibility building patrol along Asaba-Benin Expressway by Issele Asagba,



sighted a suspicious-looking man with a sack, pretending to be waiting for a vehicle.

He said as soon as the operatives alighted from their vehicle, the suspect took to his heels, abandoning the bag.

"Upon searching the abandoned bag, one pump-action gun and six live cartridges were recovered. Effort is on to arrest the fleeing suspect," Edafe added. The girl was later rushed to a hospital after passing out; she died at the hospital.

## Septuagenarian bags death sentence for murder

78-year-old man, Ojo Komolafe, has been sentenced to death by the Ondo State High Court for killing a school proprietor, Taofik Babalola.

The convict committed the offence on August 7, 2021, at Kajola community, in the Odigbo Local Government Area of the state.

He was said to have shot the deceased while the latter slept.

Thereafter, he was arrested by men of the state police command and charged with two counts of murder.

During the court proceedings, witnesses were called by the prosecutor.

Also, there were a series of arguments from both the prosecuting counsel and the defence counsel.

In his judgement, Justice Fasanmi
held that the prosecution proved its
case beyond reasonable doubt and
there was direct evidence that linked
the convict to the crime.

He said, "It is my finding that the defendant caused the death of the deceased by shooting him with a gun at close range. The defendant was also seen fleeing the place of the crime.

"On the whole, I find the defendant guilty of the two counts as charged. You (the defendant) are hereby sentenced to be hanged on the neck until you die on the first count, and seven years imprisonment for the second count."
