Court hears suit seeking PDP acting chair's removal

THE Federal High Court in Abuja has fixed November 16 to hear a suit seeking the removal of the acting Chairman of the Peoples Democratic Party. Umar Damagum.

The suit marked FHC/ ABJ/05/1343/2023, was filed by the Youth Leader of the Kwara State PDP, Haliru Mahmud.

Mahmud wants the court to determine whether the alleged refusal of Damagum to convene a meeting of the National Executive Committee for four quarters was not a breach of the PDP constitution.

According to him, going by the PDP Constitution, the PDP NEC meeting ought to hold every quarter.

He, therefore, wants "an order of perpetual injunction of this Honourable Court restraining the 2nd defendant (Damagum) from parading himself as acting National Chairman or acting in any manner whatsoever or carrying out further functions as the National Chairman of the 1st defendant (PDP)."

A'Court reserves judgment on LP, PDP suits against Sanwo-Olu **Onozure Dania**

HE Court of Appeal in Lagos, on Tuesday, reserved judgments on the cases of the Labour Party and the Peoples Democratic Party challenging the victory of Governor Babaiide Sanwo-Olu of the All Progressives Congress in the March 18 governorship election in Lagos State.

The appellate court adjourned for judgment after the hearing of the appeals by the LP and its candidate, Gbadebo Rhodes-Vivour: as well as the PDP and its candidate, Azeez Adediran, aka Jandor.

The Lagos State Governorship Election Petitions Tribunal had on September 25, dismissed the petitions by the two opposition parties challenging Sanwo-Olu's victory.

But displeased, the two parties proceeded on appeal.

At the hearing of the two appeals on Tuesday, a threeman panel, comprising Justices Justice Nimpar Yargata, Samuel Bola and Paul Bassi, took arguments from the legal teams, after which they reserved ruling to a date to be communicated to the parties.
